

**RESOLUTION NO. 210287**

**A resolution of the City of Gainesville, Florida, accepting FAA Airport Coronavirus Rescue Grant Program Grant No. 3-12-0028-049-2021 from the U.S. Department of Transportation, Federal Aviation Administration, and authorizing execution by the Mayor and the City Clerk on behalf of the City of Gainesville; and providing an immediate effective date.**

**WHEREAS**, On July 22, 2021, the Gainesville-Alachua County Regional Airport Authority (GACRAA) submitted an Airport Coronavirus Rescue Grant Application to the Department of Transportation, Federal Aviation Administration (FAA) seeking federal funds in the amount of up to \$3,547,689; and

**WHEREAS**, the FAA submitted a Grant Agreement, which constitutes an offer to the City of Gainesville and the GACRAA to be executed by the appropriate officials which, when so accepted, will constitute a Grant Agreement for \$3,547,689; and

**WHEREAS**, the FAA requires that the City of Gainesville, as the fee title owner of the property making up the Gainesville Regional Airport, and the GACRAA both approve and accept the grant offer prior to receiving federal funds; and

**WHEREAS**, the GACRAA is anticipated to adopt Resolution 21-023 to accept and authorize execution by GACRAA's CEO of the anticipated grant offer at its meeting on August 26, 2021; and

**WHEREAS**, Gainesville Regional Airport staff has requested that the City of Gainesville approve the grant offer subject to final approval by GACRAA and timely review by the City Attorney.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:**

**Section 1.** The City of Gainesville shall accept and enter into Grant Agreement 3-12-0028-049-2021 for the purpose of obtaining federal aid in the operation of the Gainesville Regional Airport under Grant Agreement 3-12-0028-049-2021 that is to be implemented and operated by the GACRAA in accordance with Chapter 2006-363, Laws of Florida.

**Section 2.** The City of Gainesville does hereby ratify and adopt all statements, representations, warranties, covenants, and agreements contained in FAA Grant Agreement 3-12-0028-049-2021, and incorporated material referred to in the said Grant Agreement, and by such acceptance, and in reliance upon the assurances of GACRAA's Chief Executive Officer that the GACRAA agrees to abide by all of the terms and

conditions of said Grant Agreement and the assurances made by GACRAA in Resolution No. 21-023, does agree to all of the terms and conditions thereof.

**Section 3.** Lauren Poe, Mayor, is hereby authorized and directed to execute said Grant Agreement 3-12-0028-049-2021 on behalf of the City of Gainesville in the amount of \$3,547,689 and Omichele Gainey, City Clerk is hereby authorized and directed to impress the official seal of the City of Gainesville and to attest to said execution.

**Section 4.** This resolution will take effect immediately upon adoption.


