My professional career has been a balanced one which includes management, staff and teaching roles in the public sector and marketing and consulting in the private sector. As a public sector manager since 1969, I have served in seven Missouri and Florida communities, each well established and culturally diverse. 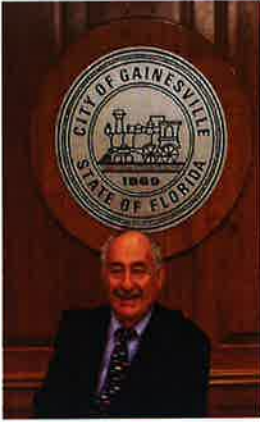
