- 3) Temporary Tipped employees have a base hourly rate of \$5.85 but the City adjusts their hourly rate of pay each pay period so that the employee earns at least \$8.05 (Florida's minimum wage). Therefore, the current hourly rate for these 2 employees is reflected as \$8.05.
