ORDINANCE NO. 0-06-07

An ordinance of the City of Gainesville, Florida, amending the Zoning Map Atlas and rezoning certain property within the City from "L-1" Limited Industrial business district to General business district, located in the vicinity of 309 Northeast 39th Avenue, providing a severability clause, and providing an immediate effective date.

ORDINANCE NO. 0-06-26

An Ordinance of the City of Gainesville, Florida, adopting an Urban Services Report which sets forth plans to provide urban services to an generally located south of the City limits, west of the vicinity of SW 34th Street and the east limits, north of the area SW 20th Avenue and east of SW 17th Street; the area is proposed for annexation by the City of Gainesville pursuant to Chapter 90-496, Special Acts, Laws of Florida, as amended, known as the Alachua County Boundary Adjustments Act; the City Manager, the City Attorney and the Clerk of the Commission, providing a severability clause, and providing an immediate effective date.

An Ordinance of the City of Gainesville, Florida, adopting an Urban Services Report which sets forth the plans to provide urban services to an area generally located south of the City limits, west of the vicinity of SW 34th Street and the east limits, north of the area east of SW 17th Street; the area is proposed for annexation by the City of Gainesville pursuant to Chapter 90-496, Special Acts, Laws of Florida, as amended, known as the Alachua County Boundary Adjustments Act; the City Manager, the City Attorney and the Clerk of the Commission, providing a severability clause, and providing an immediate effective date.
