COMPLAINT AGAINST

Gainesville City Commissioner Jack Donovan February 18th, 2010

STATEMENT OF FACTS:

Gainesville City Commissioner Jack Donovan is an elected public officer as defined under Florida law. Commissioner Donovan is serving his 2nd, 3 year term as a Gainesville City Commissioner for Gainesville District III. His current term as a Gainesville City Commissioner runs from May, 2008 until May, 2011.

On or about December 28th, 2009, while acting in his official capacity as a public officer, Commissioner Donovan directed a City of Gainesville employee, Ms. Neomia Brown, to author and sign a letter on his behalf (Exhibit One). The letter was written on official City of Gainesville stationery, addressed to "The Honorable Judge James P. Nilon."

Commissioner Donovan had the letter forwarded to Judge Nilon in an effort to influence the pending criminal sentencing of a convicted felon. In the last paragraph of the letter to Judge Nilon, Commissioner Donovan's letter states; "I urge you as the judge to recognize in your sentencing the questions of civil rights and police practices that still remain alive in this matter as well as Mr. Grapski's high motives. I hope that Mr. Grapski's sentence will be no more than probation requiring his obedience to the law, especially those governing interaction with legal authority."

RELEVENT FLORIDA STATUTE:

112.313(6):

MISUSE OF PUBLIC POSITION.--No public officer, employee of an agency, or local government attorney shall corruptly use or attempt to use his or her official position or any property or resource which may be within his or her trust, or perform his or her official duties, to secure a special privilege, benefit, or exemption for himself, herself, or others. This section shall not be construed to conflict with s. 104.31.

COMPLAINANT'S STATEMENT:

Issue One: It is my belief that Commissioner Donovan violated Florida ethics law when he directed a City of Gainesville employee to author a letter on City of Gainesville letterhead for the sole purpose of influencing a judge's sentencing decision. Assuming that the employee was on duty at the time she authored the letter for Commissioner Donovan, she was being compensated with taxpayers' funds to conduct personal business on behalf of Commissioner Donovan.

Issue Two: It is my belief that Commissioner Donovan directed that the letter be written on City of Gainesville Official letterhead in an overt attempt to have a greater influence on the judge than had the letter come from Jack Donovan, citizen of Gainesville. Commissioner Donovan's letter, written on City of Gainesville letterhead clearly gives the impression that he is advocating the official position of the City of Gainesville.

Issue 3: It is my belief that when Commissioner Donovan directed that the letter be written on his behalf to influence Judge Nilon's decision, he violated Florida ethics law. It is clear Commissioner Donovan used his his official position as a public officer, as defined by Florida law, to influence the judge to reduce the sentence of a convicted felon.

Thank you for your service to our community. Christmas blessings and a Joyful new year to you and your family.

I would like to address the sentencing of a Mr. Charles Grapski, which I understand is to occur tomorrow marning.

I have followed Mr. Grapside calleer as an outspoken activist for civiliand human rights. I confess I have not always appreciated his self-rightsousness in the midst of the flav. But I have always admired his parsistence in the defense of our fundamental freedoms.

I have also followed the events surrounding his objections to some of the ways in which the police force of the City of Alachue has conducted itself in recent times. It has seemed to me that his objections had merit and his persistence in having them investigated was warranted. I felt considerable suspicion when his was charged with a number of crimes in relation to that police force and its chief.

I understand that he has been convicted of one of the charges and will be sentenced tomorrow, with a possibility of three years in prison. I would urge you as the judge to recognize in your sentencing the questions of dvil rights and palice practices that still remain alive in this matter, as well as Mr. Grapsid's high motives. I hope that Mr. Grapsid's sentence will be no more than probation requiring his obscience to the law, especially those governing interaction with legal authorities.
