Good morning Ms. Springfield.

Thank you for your participation in the Special Magistrate for Code Enforcement Hearings process. During your presentation you stated you were recently chosen by the City Council for the City of Lake City to act as its Special Magistrate for Code Enforcement. The City Attorney has stated that a person may not serve as a Code Enforcement Special Magistrate in two jurisdictions per our Code (per Sec. 2-391 (b)(3)) and per the Florida Constitution (per Art. II, Sec. 5). With that stated you would not be eligible to serve as Special Magistrate for both agencies. Please advise if you intend to remain with the City of Lake City or be considered for the City of Gainesville.

I will need your decision as soon as possible but no later than 1PM today.
