**Interview Candidates for City Auditor (B)** 

This is a request for the City Commission to interview candidates for the City Auditor position.

Explanation: On August 21, 2014, the City Commission authorized the Human Resources/Organizational Development (HR/OD) Department to engage the services of an executive search firm in preparation of the April 2, 2015 retirement of City Auditor Brent Godshalk. Bob Murray and Associates a/k/a S. Renee Narloch & Associates conducted a search and presented a slate of highly qualified candidates to be considered at the February 5, 2015 City Commission meeting.

> The selected candidates will be interviewed on February 23, 2015 by the full City Commission. Candidates will have individual interviews with Commissioners on February 24, 2015. Candidates will have an opportunity to meet the Charter Officers, the City Auditor Staff and will receive a tour of Gainesville.
