

**AGREEMENT BETWEEN
THE CITY OF GAINESVILLE
AND
GOLD NUGGET UNIFORM DBA / ARGO UNIFORM COMPANY**

THIS AGREEMENT is made and entered into this 12 day of February 2019, by and between the City Of Gainesville, Florida, a municipal corporation organized under the laws of the State Florida, hereinafter referred to as "City" and GOLD NUGGET UNIFORM DBA / ARGO UNIFORM COMPANY, hereinafter referred to "CONTRACTOR".

WHEREAS, the CITY desires to enter into an agreement with CONTRACTOR to provide uniforms for the Gainesville Police Department which incorporates BID GPDC-190009-MS into this Agreement;

WHEREAS, the Contractor is awarded line numbers 1 through 16, 18 through 48;

NOW THEREFORE, the parties hereto agree as follows:

SCOPE OF SERVICE

The CONTRACTOR shall provide uniforms to the Gainesville Police Department based on the bid GPDC-190009-MS and the specifications listed in bid document. (Attachment I – Bid Document GPDC-190009-MS).

COMPENSATION

Payment will be due the CONTRACTOR 30 days after receipt of acceptable equipment and receipt of acceptable invoices. Invoices must be created by the CONTRACTOR and shall not be produced by CITY personnel on the CONTRACTOR's behalf. The CONTRACTOR must accept payment either by Visa, within Visa limits, or by electronic funds transfer (EFT). The cost of the contract shall not exceed \$120,000 per year.

EFFECTIVE DATE AND TERM


This Agreement is in effect for the time period beginning date of the award notice for a four year period as stated in the original bid document. There is a one additional year optional renewal and may be extended if both parties mutually agree in writing.

GENERAL CONDITIONS

Termination: If the CONTRACTOR fails to fulfill any of its obligations under this Agreement, or otherwise through no fault of the CITY, such failure shall be considered a default and entitle, but not obligate the CITY to suspend or terminate the Agreement in part or whole at the CITY's discretion. If the CONTRACTOR fails to cure the default with thirty (30) days after receipt of written notice from the CITY, the contract in whole or part will be terminated with the CONTRACTOR. In event of termination the CITY shall pay CONTRACTOR the full amount due for goods satisfactorily delivered and/or services satisfactorily rendered.




