16	WHEREAS, On July 27, 2009, the City Commission of the City of Gamesvine, Florida
17	adopted Resolution No. 090208 which approved a Proposed Tentative General Government
18	Financial and Operating Plan Budget for the City of Gainesville, Florida; and
19	WHEREAS, on July 27, 2009, the City Commission adopted Resolution No. 090207
20	approving the proposed millage rate necessary to fund the Proposed Tentative Genera
21	Government Financial and Operating Plan Budget; and
22	WHEREAS, on July 28, 2009, the City Commission adopted Resolution No. 090269
23	that amended Resolution No. 090207, and adopted a revised and corrected proposed millage rate
24	necessary to fund the Proposed Tentative General Government Financial and Operating Plan
25	Budget; and
26	WHEREAS, pursuant to law and utilizing the rate established in Resolution No
27	090269, on or about August 18, 2009, the Alachua County Property Appraiser mailed a Notice of
28	Proposed Property Taxes to each taxpayer listed on the current year's assessment roll; and
29	WHEREAS, the said Notice of Proposed Property Taxes advised the recipients of a
30	public hearing to be conducted by the City Commission for consideration of its Amended

5	Section 1. The proposed millage rate of 4.3963 mills to fund the Amended Tentative
6	General Government Financial and Operating Plan Budget for the City of Gainesville's 2009-
7	2010 fiscal year is hereby approved for further consideration in accordance with applicable law.
8	Section 2. The General Fund millage rate approved herein is equal to the rolled-back
9	rate of 4.3963 by 0.0 mill, which results in a 0.0% increase in property taxes.
10	Section 3. A public hearing will be held to consider the final millage rate and budget for
11	general municipal purpose on Thursday, the 17 <sup>th</sup> day of September, 2009, at 6:00 p.m. or as
12	soon thereafter as the matter may be heard in the City Hall Auditorium on the first floor of City
13	Hall, 200 East University Avenue, Gainesville, Florida.
14	Section 4. The City Manager is hereby authorized and directed to prepare and publish all
15	necessary and required notices prior to the hearing established herein, and to provide a copy of
16	this resolution to all parties as may be required by law.
17	Section 4. This resolution shall take effect immediately upon its adoption.
