	Libraries	1 for each 200 1,000 square feet of gross floor area	20 percent of required number of vehicle parking

- **Section 2.** It is the intention of the City Commission that the provisions of Section 1 of
- 4 this ordinance shall become and be made a part of the Code of Ordinances of the City of
- 5 Gainesville, Florida, and that the Sections and Paragraphs of this Ordinance may be renumbered
- 6 or relettered in order to accomplish such intentions.
- 7 **Section 3**. If any section, sentence, clause or phrase of this ordinance is held to be
- 8 invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no
- 9 way affect the validity of the remaining portions of this ordinance.
- Section 4. All ordinances, or parts of ordinances, in conflict herewith are to the extent of
- such conflict hereby repealed.
- Section 5. This ordinance shall become effective immediately upon final adoption.
