

**AMENDMENT TO  
THE  
AGREEMENT BETWEEN  
THE CITY OF GAINESVILLE AND  
GOLD NUGGET UNIFORM, DBA ARGO UNIFORM COMPANY**

**THIS AMENDMENT** is made and entered into by and between the CITY OF GAINESVILLE, FLORIDA – POLICE DEPARTMENT, a municipal corporation (“CITY”) organized under the laws of the State of Florida, and MUNICIPAL EMERGENCY SERVICES, INC. (“CONTRACTOR”), a corporation authorized to do business in Florida.

**WHEREAS**, the CITY and Gold Nugget Uniform, DBA Argo Uniform Company entered into an agreement dated February 12, 2019, for uniforms for the Gainesville Police Department (attached hereto as an Exhibit); and

**WHEREAS**, in May 2021, the CONTRACTOR purchased/acquired Gold Nugget Uniform DBA /Argo Uniform Company and is now operating under the name Municipal Emergency Services, Inc.; and

**WHEREAS**, the CONTRACTOR wishes to assume The Agreement Between the City of Gainesville and Gold Nugget Uniform, DBA Argo Uniform Company; and

**WHEREAS**, the CITY desires to transfer the contractual relationship previously held in the name of Gold Nugget Uniform, DBA Argo Uniform Company to the CONTRACTOR;

**NOW, THEREFORE**, the parties agree as follows:

1. The CITY hereby assigns the rights and obligations under the terms and conditions of this Agreement to the CONTRACTOR.
2. The CONTRACTOR hereby accepts assignment and assumes responsibility for performance of all the terms and conditions of this Agreement and shall be obligated under all terms and conditions of said Agreement as if it was an original signatory thereto.
3. By executing this Amendment, the CITY consents to pay the CONTRACTOR the sums for service as stipulated in the original Agreement.
