Mr. Robinson is a Certified Environmental Professional (National Association of Environmental Professionals) and a Professional Wetland Scientist (Society for Wetland Scientists) with academic experience and training in wildlife management, wildlife field studies, wetland ecology, coastal ecology, mitigation banking, vertebrate biology, vertebrate taxonomy, botany, and ecosystem ecology. He also has had significant training in systematic botany including taxonomy of the grasses, rushes, and sedges, and general ecology with emphasis on coastal ecology. Mr. Robinson's expertise includes aerial photographic interpretation, technical writing, and literature searches. He has been involved with wetland studies on over 1,000,000 acres of land and has extensive experience in coordination with regulatory agencies, site analysis, and development planning. Mr. Robinson has over 28 years professional experience in environmental consulting. As CEO of a 200-person firm, Mr. Robinson is involved with large-scale planning and permitting, including projects up to 125,000 acres; he is recognized for implementing innovative approaches and solutions to environmental issues, and resolution of disputes.
