CALL TO ORDER

The CDC meeting was called to order at 5:15 p.m.

ROLL CALL

ADOPTION OF THE AGENDA

The CDC agenda for August 28, 2008 was adopted as circulated.

ADOPTION OF THE MINUTES

DISCUSSION OF PENDING REFERRALS

070604. Annexation of Strategic Ecosystems (B)

The Community Development Committee (CDC) directed staff to bring back to this meeting a preliminary analysis of the Alachua County Environmental Protection Department (ACEPD) eight recommendations as presented at the July 24, 2008 CDC meeting.

The ACEPD's presentation of eight recommendations is as follows:

Green Infrastructure Within City:

- 1) Track green infrastructure with new development (open space, previous areas, tree canopy, habitat and SE protected);
- 2) Coordinate with county tracking process;
- 3) Use GIS to provide visual representation of Infrastructure (good planning tool and assists with identifying areas for protection);
- 4) Promote green building and LID techniques.

Wetlands annexed by City of Gainesville:

- 5) Support county protection standards and encourage Low Impact Development (UD) standards for undeveloped areas, wetlands linked to creek, streams, and lakes or within Strategic Systems;
- 6) Maintain city standards for redevelopment areas, areas with existing buffer

impacts or lack of buffers, or areas of high or medium density residential or other intensive land use.

Strategic Ecosystems within City Limits:

- 7) SE annexed that are part of greenbelt and currently undeveloped: adopt County approach;
- 8) SE annexed within more dense urban areas or with existing Intensive land use, consider hybrid approach with similar protection standards but more intensive development approach.

In response to the ACEPD recommendations, the CDC heard a preliminary analysis and recommendation discussion by staff as listed below.

Tracking Green Infrastructure: For each new development, EPD records the acreage of wetlands and their buffers, surface waters and their buffers, significant geological features and their buffers, strategic ecosystems, listed species habitat, 100-year floodplain, significant habitat, other natural areas, community green spaces, stormwater management areas, and landscaped areas, and recommended that the city do the same. I record the acreage of wetlands on each new site plan, but the city doesn't record the other features.

Recommendation: We can track some or all of the features that the county does. If we wish to track all the features, we will have to change our requirements for site plans.

GIS: EPD also recommended that the city "use GIS to provide visual representation of infrastructure." I am using GIS to review all new site plans.

Recommendation: I can coordinate with the county to determine how they are providing a visual representation of infrastructure.

Green Building and Low-Impact Development (LID): EPD recommended that the city promote these practices.

Recommendation: Coordinate with Building Department to determine how the city is promoting these practices now.

Wetlands: EPD recommended that the city apply county standards to wetlands in undeveloped areas or connected to creeks and lakes.

Recommendation: I believe the consensus was to retain existing city standards for wetland protection in areas outside of annexed Strategic Ecosystems.

Strategic Ecosystems: EPD recommended that the city apply county standards to strategic ecosystems "that are part of greenbelt and currently undeveloped." Recommendation: Adopt two tiers of environmental regulations. For properties annexed into the City from Alachua County, acknowledge County Strategic Ecosystems designation and apply enhanced City environmental protections to be drafted by staff. For properties currently within City limits apply enhanced City environmental protections to be drafted by staff. Staff is currently reviewing the substance and distinctions between County Strategic Ecosystems and the City's Significant Ecological Overlay District and will bring back language for the Committee to review.

The CDC directed staff: 1) to meet with County staff to refine definitions; and 2) staff

will bring back to the CDC a list of ecosystems elements, mechanical applications in an organized framework.

RECOMMENDATION

The Community Development Committee will hear from staff a preliminary analysis of the eight recommendations from the Alachua County Environmental Protection Department presented to the Community Development Committee on July 24, 2008.
