

RESOLUTION NO. 060079

PASSED: June 12, 2006

A Resolution of the City Commission of the City of Gainesville, Florida; establishing maximum rates for off street parking, parking meters, parking lots and parking garages in accordance with Chapter 26, Article III, Division 2, City of Gainesville Code of Ordinances; authorizing the City Manager to establish operational criteria for group rate parking; authorizing the City Manager to establish rates up to the maximum rate; providing a repealing clause; providing an immediate effective date.

WHEREAS, Chapter 26, Division 2 of the Code of Ordinances of the City of Gainesville provides that parking rates for parking meters, parking lots and parking garages be established by resolution of the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:

Section 1: The City Commission finds that the following categories of on-street and parking lot parking require the deposit in parking meters of coin or coins or payment by other mode of payment compatible with the technology of the parking meter. The following rates are maximum rates:

1. Short term metered zones, not exceeding 4 hours, hourly rate ... \$0.50 per hour.
2. Long term metered zones, in excess of 4 hours, hourly rate \$0.25 per hour.

Section 2: The City Commission finds that payment for garage parking requires payment by mode compatible with the technology of the parking equipment installed in the garage. The following categories and maximum rates are established for garage parking:

Daytime (6:00 A.M. to 6:00 P.M.)

1. Hourly fee for first 6 hours\$1.00
2. Over 6 hours\$6.00
3. Lost Ticket\$6.00

Nighttime (6:00 P.M. to 6:00 A.M)

4. Nightly flat rate\$5.00
5. Lost Ticket\$6.00

Special Event (Event Designated by City Manager)

6. Daily flat rate\$5.00

Contract Parking

1. One month..... \$40.00
2. Three (3) months advanced purchase \$114.00 (\$38.00/mo)
3. Six (6) months advanced purchase \$216.00 (\$36.00/mo)
4. Twelve (12) months advanced purchase \$420.00 (\$35.00/mo)
5. Access cards for contract parking have unlimited access to the garage (24 hours/7 days per week) including access during special events.
6. Access cards may be paid for on a quarterly basis.

Group Rate Parking

1. Group rates.....\$40.00 per month
2. The City Manager is authorized to establish the operational criteria, such as minimum number of individuals needed to total a group, days of week/hours of day group rate parking, payment options for the group, and other similar factors, for group rate parking.

Section 3: The City Commission finds that the maximum rate for restricted long term off street parking in city parking lots (permit parking) is as follows:


1. Permit parking is established in six (6) month intervals described as January to June and July to December.
2. Permit parking requires a six (6) month advanced purchase \$180.00 (\$30.00/mo) for all or any portion of a 6 month period
3. Permit parking may be paid by permittee on a quarterly basis.

Section 4: The City Manager is authorized to establish all parking rates listed in this Resolution up to the maximum rate listed.

Section 5: Resolution 040542 (11-22-2004), 050704 (12-12-05), and all other resolutions or parts of thereof in conflict herewith are to the extent of such conflict hereby repealed.

Section 6: This Resolution shall become effective immediately upon adoption.


