An ordinance of the City of Gainesville, Florida, amending the fees landlord permits in Appendix A – <i>Schedule of Fees, Rates and Charges</i> of Code of Ordinances; providing directions to the codifier; providing severability clause; providing a repealing clause; and providing immediate effective date.			
10	WHEREAS, notice was given as required by law that the text of the City of Gainesville		
11	Code of Ordinances be amended; and		
12	WHEREAS, at least ten days' notice has been given once by publication in a newspaper		
13	of general circulation notifying the public of this proposed ordinance and of public hearings in		
14	the City Hall Auditorium located on the first floor of City Hall in the City of Gainesville; and		
15	WHEREAS, public hearings were held pursuant to the notice described above at which		
16	hearings the parties in interest and all others had an opportunity to be and were, in fact, heard.		
17	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE		
18	CITY OF GAINESVILLE, FLORIDA:		
19	Section 1. Appendix A – Schedule of Fees, Rates and Charges of the Code of		
20	Ordinances is amended as follows. Except as amended herein, the remainder of Appendix A –		
21	Schedule of Fees, Rates and Charges remains in full force and effect.

3	3. Transfers of permit to new owner(s)			
4 5 6 7	4. Multiple dwelling units: Where two or more dwelling units requiring a landlord permit are located on a single parcel of property and are owned by the same owner(s), one unit shall be subject to the full permit fee and each additional unit shall receive a 50% discount.			
8 9	5. Late fee: A late fee of 25% of the permit fee shall be assessed when an application and full payment is not received by the due dates specified herein.			
10	Section 2. It is the intent of the City Commission that the provisions of Section 1 of this			
11	ordinance shall become and be made a part of the Code of Ordinances of the City of Gainesville,			
12	Florida, and that the sections and paragraphs of the Code of Ordinances may be renumbered or			
13	relettered in order to accomplish such intent.			
14	Section 3. If any word, phrase, clause, paragraph, section or provision of this ordinance			
15	or the application hereof to any person or circumstance is held invalid or unconstitutional, such			
16	finding shall not affect the other provisions or applications of this ordinance that can be given			
17	effect without the invalid or unconstitutional provision or application, and to this end the			
18	provisions of this ordinance are declared severable.			
19	Section 4. All ordinances or parts of ordinances in conflict herewith are to the extent of			
20	such conflict hereby repealed.			
21	Section 5. This ordinance shall become effective immediately upon adoption.
