Motion:

- 1. That the Finance Committee request the City Commission to adopt a binding resolution at its March 17, 2022 meeting.
- 2. Calling for the divestment of current City holdings in Russian or Belarusian securities.
- 3. Requesting the same for the Employee Pension Board; for the Police Officers' and Firefighters' Pension Boards and for the Retiree Health Insurance Trust Fund.
- 4. Creating a new investment policy not to invest in Russian or Belarusian securities in the future; and request the same for the Employee Pension Board; for the Police Officers' and Firefighters' Pension Boards and for the Retiree Health Insurance Trust Fund.
- 5. Denouncing war and asking for a peaceful resolution; stating that Gainesville welcomes refugees from this conflict and other conflicts; and reaffirming Gainesville's Sister City in Russian, maintaining culture ties and diplomacy.
