

RESOLUTION NO. 140684

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA, AUTHORIZING THE GRANT OF A PERPETUAL EASEMENT TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE.

ON MOTION of Commissioner POE, seconded by Commissioner Carter, the following Resolution was adopted;

WHEREAS, the State of Florida Department of Transportation proposes to construct or improve State Road No. 26, Section No. 26130, Segment No. 4307591, in Alachua County, Florida; and

WHEREAS, it is necessary that portions of certain right of ways, Northeast 14th and 15th Streets and Southeast 14th and 15th Streets, maintained by **THE CITY OF GAINESVILLE, FLORIDA**, be used by the State of Florida Department of Transportation; and

WHEREAS, said use is in the best interest of the City; and

WHEREAS, the State of Florida Department of Transportation has made application to said City to execute and deliver to the State of Florida Department of Transportation a Perpetual Easement, or easements, in favor of the State of Florida Department of Transportation, for the purpose of signal light replacement, etc., thereon with the construction to be undertaken by the Department, in State Road 26 adjacent thereto, and said request having been duly considered.

NOW THEREFORE, BE IT RESOLVED by the City Commissioners of **THE CITY OF GAINESVILLE, FLORIDA**, that the application of the State of Florida Department of Transportation for a Perpetual Easement, or easements, is for transportation purposes which is in the public or community interest and for public welfare; that a Perpetual Easement, or easements, in favor of the State of Florida Department of Transportation in **THE CITY OF GAINESVILLE, FLORIDA**, should be drawn and executed by the Mayor on behalf of the City.


BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded forthwith to the State of Florida Department of Transportation at Lake City, Florida.




