DISCUSSION OF PENDING REFERRALS[180402.](#)**Construction Contracts of a Certain Size - Percentage of Apprenticeship Jobs if Awarded (B)**

Explanation: At the September 20, 2018, City Commission Meeting, the Commission expressed interest in the city requiring contractors to have apprenticeship opportunities as a requirement for the city to do business with them.
