Park Trespass Provisions Referral to the Recreation, Cultural Affairs and Public Works Committee (B)

This item requests the Gainesville City Commission refer discussion of park trespass provisions on City park property to the Recreation, Cultural Affairs and Public Works Committee (RCAPW).

Assistant City Manager Paul Folkers introduced Captain Brian Helmersen, who provided some history on the Trespass Ordinance and then introduced Corporal Duane Diehl and Officer Michael Mosher, of the Gainesville Police Department (GPD) Downtown Unit. Cpl. Diehl gave a presentation on the need for a Trespass Ordinance that is based on location so that it doesn't single out individuals or groups. Trespass has not been available for two years because of legal concerns, but GPD is

asking to have the ability to trespass restored. They would like the Committee to recommend to the City Commission that they authorize the City Attorney to draft an ordinance covering all City of Gainesville parks for approval by the Commission. The Committee voted unanimously to ask staff to come back to the September meeting with specific suggestions for the ordinance, including an appeal process.

RECOMMENDATION The City Commission refer the discussion of a park trespass ordinance to the Recreation, Cultural Affairs and Public Works Committee for consideration.

Paul Folkers reminded the Committee of the recommendations that had been approved at the May meeting. Members of the Friends of Reserve Park and local business owners emphasized that they feel it is important for the City to set boundaries and ensure a park no matter what happens with the building. Ken Armstrong of the Alachua County Housing Authority provided a handout and gave a brief presentation on a concept to utilize the property for the Housing Authority's offices, senior (and eventually assisted living) housing, affordable housing, and an event space. They are indicated and interest in working to utilize the space to the satisfaction of the neighborhood and the City. Friends of Reserve Park is strongly interested in having a City park on the site. It was unanimously decided that the Committee accept staff recommendations.

RECOMMENDATION

The Committee finalize recommendations to the City Commission including the following: 1) hear a presentation with options for the proposed "Reserve Park", 2) approve the Committee's recommendation to name the park "Reserve Park" and dedicate the park as a memorial to the reserve/citizen soldier, 3) approve the Committee's proposed boundaries for the park, 4) provide input on the proposed park features, 5) direct staff to develop plans for cleaning and maintaining at least a portion of the proposed park area

for FORP to hold veterans related events and potentially other limited public access, 6) direct City staff to prepare a CIP project request for "Reserve Park" for the next CIP update, and 7) direct City staff to proceed with development of an RFP for use of the building returning to the Committee and City Commission for input before finalizing and releasing the RFP.

Paul Folkers introduced the item and Jean Chalmers of the Golfview neighborhood, who spoke about the need to improve the infrastructure of this hundred-year-old neighborhood. Ms. Chalmers then introduced Kim Tanzer, former Dean of Architecture at the University of Virginia, who spoke about her interest in making Golfview a pilot neighborhood to allow Public Works and GRU staff to work with her Spring Design Studio at UF, to guide her students to help solve the issues associated with updating older infrastructure. Commissioner Warren brought up a concern about the location selection for this kind of project, but she is otherwise excited about this possibility. It was agreed that Ms. Tanzer would work with staff to firm up specifics on how the City can be involved and benefit from her project, and bring that back to the Committee at a later date.

RECOMMENDATION *The Committee hear a presentation and proposal from residents of the Golfview neighborhood on Integrated 21st Century Infrastructure.*
