Temporary Emergency Homeless Assistance Plan (B)

During the October 24, 2005, City Commission meeting, Commissioner Jack Donovan made a presentation on the need for immediate shelter and services for persons who are homeless or at risk of becoming homeless. The City Commission agreed to discuss proposals to meet these needs at the November 14, 2005, City Commission meeting.

### ..Explanation

At the October 24, 2005, City Commission meeting, Commissioner Jack Donovan made a presentation on the need for addressing the immediate shelter and services needs of persons who are homeless or at-risk of becoming homeless over the next four to six months. The needs and some options and costs are outlined in a handout that was provided by Commissioner Donovan. The need statement identified various segments of the current homeless population of Gainesville in need of help, as well as those who are at risk of becoming homeless.

Commissioner Donovan's presentation on needs included a range of costs summarized below:

Shelter for current homeless persons: Up to \$149,000 Services for currently homeless persons: Up to \$189,000 Prevention services for at-risk persons: Up to \$247,500

Total: Up to \$585,500

The City Commission agreed to discuss proposals to address these needs at its November 14, 2005, meeting. Commissioner Donovan said he would bring several alternative plans for this purpose.

Research by City staff indicates that the City Commission has approved \$70,310 in the FY 2005-06 CDBG and HOME budgets to support programs to assist the homeless through Gainesville Community Ministry, Interfaith Hospitality Network, Peaceful Paths and St. Francis House. The City served as the applicant and grantee for \$99,101 provided from Supportive Housing Grant funds for transitional housing and support services for mentally ill homeless persons at Meridian Behavioral Health Care and for \$106,215 provided for transitional housing and support services for homeless veterans at VETSPACE. The City assisted with the Alachua County Coalition for the Homeless and Hungry's application for State Homeless Assistance Challenge Grants that provided \$60,000 for facilities and services at several homeless organizations. The City participates in joint applications with Alachua County that result in SHIP Special Needs funding for various organizations serving the homeless. The City Commission has allocated \$5,000 for Sister Hazel's Clinic (medical care assistance) and \$15,000

for homeless youth at The Preserve from general funds. Finally, \$50,000 was set aside in the FY 2005-06 CDBG budget for a yet-to-be determined capital improvement initiative for the homeless, in anticipation of recommendations from the homeless summit committees.

With regard to future funding, staff is proposing that next year's competitive allocation process for CDBG and HOME be handled in an RFP (Request for Proposals) fashion. Using this approach, the City would specify in an RFP those kinds of services or programs that it would consider for funding. Based on recent discussions, staff has identified a group of core services or programs that we believe are appropriate for the City to support. Thus, the proposed priorities for CDBG and HOME funding would be those services or programs that address one or more of the following: housing; assistance to the homeless; recreation programs for children and youth, provided they supplement the City's own recreation programs; and support for employment and job training initiatives. This new approach could increase funding for homeless services from block grant funds.

### ..Fiscal Note

Funding for the components for Commissioner Donovan's proposal has not been identified. Prior discussions at City Commission meetings suggested funding might come from reallocation of budgeted funds, from City Commission contingency funds (\$150,000 is available in City Commission contingency funds), or from prioritization of other revenues.

### ..Recommendation

Recommended Motion: The City Commission: 1) discuss Commissioner Jack Donovan's proposals (or other proposals to be presented at the 11/14/05 City Commission meeting) to provide temporary emergency homeless services; 2) provide direction to staff on which portions of the proposals the City Commission wishes to implement; 3) if appropriate, authorize staff to issue an RFP at the earliest opportunity for local service providers that are willing to provide the additional services and cold night shelter for homeless persons during the winter months; 4) allocate a portion of City Commission contingency funds, reappropriate bugeted funds, and/or assign funds from the \$300,000 in new, unallocated ad valorem revenues for this purpose; and 5) initiate plans for encouraging, receiving and utilizing donations from community members.
