RUC CURRENT ACTION ITEMS

090168.	Efficacy and Safety of Fluoridating Our Public Water Supply (B)

Explanation: GRU began water fluoridation in 1949 and has continued the practice for the past 60 years. GRU adds fluoride to the water supply to bring the fluoride concentration to 0.8 mg/L which is within the U.S. Public Health Service and CDC recommended optimal range of 0.7 mg/L to 1.2 mg/L. This level of fluoride is optimal for preventing dental decay in both children and adults.

The consensus among public health and safety organizations is that fluoridation is not only safe, but strongly recommended for community water systems. The following is a list of the most widely recognized organizations that recommend fluoridation of public water supply: 1. Florida Department of Health; 2) World Health Organization (WHO); 3) Centers for Disease Control (CDC); 4) American Water Works Association (AWWA); 5) National Cancer Institute; and 6) American Dental Association (ADA)

In July 2009, Karen Eberly requested from GRU a reference to one long-term toxicological study done on the product that GRU uses to fluoridate our water supply (hydrofluosilcic acid) which supports the certification required by ANSI/NSF Standard 60. GRU provided Ms. Eberly a letter dated July 31, 2009 which indicated that toxicological evaluations have been performed on the potential constituents of hydrofluosilicic acid. These evaluations are discussed as part of the NSF Fact Sheet on Fluoridation Chemicals (attached as backup).

Ms. Eberly also requested of the City Commission that the topic of fluoride in the drinking water supply be placed on the Regional Utilities Committee agenda. She distributed copies of a 28-minute DVD on this topic to the City Commissioners. A copy of the video can also be viewed at www.fluoridealert.org <http://www.fluoridealert.org>.
