INTRODUCTION: Gainesville Regional Utilities (GRU) General Manager for Utilities Mike Kurtz gave introductions.

PRESENTATION: GRU Assistant General Manager for Strategic Planning Ed Regan and GRU Purchasing Manager Ruth Davis gave presentations.

NOTE: Chair Hanrahan left the meeting room at 6:53 PM and passed the gavel to Chair Pro Tem Chestnut.

Chair Pro Tem Chestnut recognized Citizens Joshua Dickinson, David Harlos and Dian Deevey who spoke to the matter.

MOTION: Commissioner Braddy moved and Commissioner Nielsen seconded to approve: 1) The final draft of the Request for Proposals (RFP) entitled "Scope of Services for Independent Consultation on Meeting the Future Electrical Supply Needs of the Gainesville Community" as modified in (Appendix B, page 13 of 16 making number 7, number 2 on the list of questions and concerns); 2) select the due date of September 7, 2005, for the proposals received in response to the RFP; and 3) authorize staff to issue the RFP.
