State under a different address. **With the blessing of GOD, even I can prove that the Warranty Deed of the property located at 1010 West University Ave; Gainesville, FL. 32601 submitted on 26<sup>th</sup> January, 1982 has fraudulent information in it.**

I am requesting all of you to debate with me in the presence of the Gainesville Community whether the ICG is a Civil or Criminal matter. It is very difficult to make all of you to understand in three minutes during citizen comments about the ICG matter. It is your responsibility as Mayor and City Commissioners to deal with this matter.
