*Ed Bielarski gave an brief introduction.*

*Claudia Rasnick made a presentation.*

*Discussed liquidity/reserves and debt service schedule projections through 2047. Staff plans to create policy to address cash reserves (end of calendar year). Since GREC was purchased, staff is able to revisit the amount of reserves needed moving forward, and hopes to use reserves to optimize rates. Some considerations for reserves are preserving a satisfactory bond rating both in alignment with one bond resolution and external credit rating agencies, i.e. Moody's, Fitch, etc. Staff requests that commercial paper be increased to 125 mil. This will help utility to borrow cash to*

*fund operations at a lower cost (at approximately 45 basis points) over a multi-year period.*
