14	severability clause; and providing an immediate effective date.

17	WHEREAS, Chapter 90-496, Special Acts, Laws of Florida, created the "Alachua County			
18	Boundary Adjustment Act" which sets forth procedures for establishing municipal reserve areas and			
19	for adjusting the boundaries of municipalities through annexations; and			
20	WHEREAS, Chapter 90-496 was amended by Chapter 91-382 and Chapter 93-347,			
21	Special Acts, Laws of Florida, (hereinafter collectively referred to as "the Act") which requires a			
22	municipality to prepare and adopt by nonemergency ordinance, a report setting forth the plans to			
23	provide urban services to any reserve area prior to commencing the annexation procedures under			
24	the Act; and			
25	WHEREAS, the City of Gainesville is planning to commence the annexation of certain			
26	unincorporated areas, as more specifically described in this Ordinance, that are located within its			
27	Reserve Area as defined in the Act and as redesignated by the Board of County Commissioners of			
28	Alachua County; and			
29	WHEREAS, pursuant to law, at least ten days notice has been given prior to adoption by			
30	publication in a newspaper of general circulation notifying the public of this proposed Ordinance			

and of a Public Hearing to be held in the City Commission meeting room, First Floor, City Hall, in
the City of Gainesville; and

WHEREAS, Public Hearings were held pursuant to law, at which hearings the parties in
interest and all others had an opportunity to be and were, in fact heard.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:

Section 1. The Urban Services Report, a copy of which is attached as Exhibit "A" and incorporated herein as if set forth in full, sets forth the plans to provide urban services to an area generally located south of the vicinity of SW 20th Avenue, west of SW 34th Street and the City limits, north of SW Archer Road and the City limits, and east of the vicinity of Interstate 75, and is hereby approved and adopted for that certain area as more specifically described in the Urban Services Report.

Section 2. The City Manager is directed to file a copy of this Ordinance and the accompanying Urban Services Report with the Board of County Commissioners of Alachua County and to commence the annexation of the area defined in the Urban Services Report. The City Attorney and Clerk of the Commission are authorized to prepare and advertise the appropriate ordinance(s).

Section 3. If any word, phrase, clause, paragraph, section or provision of this ordinance or the application hereof to any person or circumstance is held invalid or unconstitutional, such finding shall not affect the other provisions or applications of the ordinance which can be given effect without the valid or unconstitutional provisions or application, and to this end the provisions of this ordinance are declared severable.

3	Section 5. This Ordinance shall become effective immediately upon adoption.
