Thank you for submitting the proposed modification to the Second Amendment to License Cancellation and Termination Agreement on March 2, 2017 for staff consideration.

Per prior electronic communication on March 6, 2017, staff recommended removal of the First Amendment to the Amended and Restated Contract for Sale and Purchase and the Second Amendment to License Cancellation and Agreement at the March 2, 2017 City Commission meeting.

Based upon consultation with City Management and the City Attorney's Office, staff is not prepared to move forward with the proposed modification at this time (MCG Parking LLC does not relinquish rights to replacement parking under Paragraph 18b of the License Agreement and Section 18b is reinstated as originally written).
