18	hearing was held by the City Plan Board on September 24, 2009; and
19	WHEREAS, the City Commission finds that the rezoning of the property described herein
20	will be consistent with the City of Gainesville 2000-2010 Comprehensive Plan; and
21	WHEREAS, at least ten (10) days notice has been given of the public hearings once by
22	publication in a newspaper of general circulation notifying the public of this proposed ordinance
23	and of a Public Hearing in the City Commission meeting room, First Floor, City Hall, in the City
24	of Gainesville; and
25	WHEREAS, notice has also been given by mail to the owner whose property will be
26	regulated by the adoption of this Ordinance, at least ten days prior to the adoption of this
27	ordinance; and

1	WHEREAS, the Public Hearing was held pursuant to the published and mailed notice
2	described above at which hearing the parties in interest and all others had an opportunity to be
3	and were, in fact, heard.
4	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE
5	CITY OF GAINESVILLE, FLORIDA:
6	Section 1. The Zoning Map Atlas of the City of Gainesville is amended by rezoning the
7	following described property from the zoning category of "BUS: General business district" to
8	"BA: Automotive-oriented business district":
9 10 11	See Legal Description attached hereto as Exhibit "A", and made a part hereof as if set forth in full.
12	Section 2. The City Manager is authorized and directed to make the necessary changes in
13	the Zoning Map to comply with this Ordinance.
14	Section 3. If any word, phrase, clause, paragraph, section or provision of this ordinance
15	or the application hereof to any person or circumstance is held invalid or unconstitutional, such
16	finding shall not affect the other provisions or applications of the ordinance which can be given
17	effect without the invalid or unconstitutional provisions or application, and to this end the
18	provisions of this ordinance are declared severable.
19	Section 4. All ordinances, or parts of ordinances, in conflict herewith are to the extent of
20	such conflict hereby repealed.
