An ordinance of the City of Gainesville, Florida; providing a temporary moratorium on building permits, zoning permits, subdivision approvals, special exceptions, variances, site plan approvals or any other official action of the City of Gainesville permitting or having the effect of permitting back-out parking as provided in the Master Plan and Land Development Regulations for the College Park Neighborhood located north of West University Avenue and south of NW 5th Avenue, between NW 20th Terrace and NW 20th Street between NW 3rd Avenue and NW 5th Avenue on the west side and NW 15th Street on the east side; and that area north of West University Avenue and south of NW 7th Avenue, between NW 15th Street on the west side and NW 13th Street on the east side, located within the City of Gainesville and as more specifically described in this ordinance; providing a procedure for extraordinary hardship; providing a severability clause; and providing an immediate effective date.

#### RECOMMENDATION

City Manager to the City Commission - The City Commission authorize the City Attorney to extend the moratorium on permitting back-out parking in the College Park Neighborhood for an additional 120 days.
