4 **An Ordinance of the City of Gainesville, Florida, annexing a portion of**
5 **the City of Gainesville Reserve Area pursuant to Chapter 90-496, as**
6 **amended, Special Act, Laws of Florida, known as the Alachua County**
7 **Boundary Adjustment Act; making certain findings; including within the**
8 **corporate limits of the City of Gainesville, Florida, that certain compact**
9 **and contiguous area generally located south of the City limits and north**
10 **of Butler Plaza and Windmeadows Apartments, west of S.W. 34th Street**
11 **and the City limits up to and including I-75, and north of the vicinity of**
12 **S.W. Archer Road and the City limits, as more specifically described in**
13 **this Ordinance; providing for inclusion of the area in Appendix I of the**
14 **City Charter; providing for a referendum election; providing directions**
15 **to the City Manager and Clerk of the Commission; providing ballot**
16 **language; providing for land use plan and zoning regulations; providing**
17 **for enforcement of Alachua County land use plan, zoning and subdivision**
18 **regulations; providing for persons engaged in any occupation, business,**
19 **trade or profession; providing a severability clause; and providing**
20 **effective dates.**

23 **WHEREAS**, Chapter 90-496, Special Act, Laws of Florida, as amended by Chapter 91-382
24 and Chapter 93-347, Special Acts, Laws of Florida, created the "Alachua County Boundary
25 Adjustment Act" (hereinafter collectively referred to as "the Act") which sets forth procedures for the
26 annexation of contiguous, compact, unincorporated territory within a municipality's reserve area; and

27 **WHEREAS**, on January 10, 2006, the Board of County Commissioners of Alachua County
28 designated the Reserve Area for the City of Gainesville pursuant to the Act; and

29 **WHEREAS**, on July 16, 2008, the City Commission of the City of Gainesville, on second
30 reading, adopted Ordinance No. 080080 which adopted the Urban Services Report setting forth the
31 plans to provide urban services to that portion of the Reserve Area proposed to be annexed in
32 accordance with the procedures provided in the Act; and

1 **WHEREAS**, a copy of the Urban Services Report was filed with the Alachua County Board
2 of County Commissioners; and

3 **WHEREAS**, the City of Gainesville desires to annex a certain portion of its Reserve Area
4 which is compact and contiguous to the present corporate limits of the City; and

5 **WHEREAS**, pursuant to law, at least 10 days notice has been given by publication in a
6 newspaper of general circulation notifying the public of the first Public Hearing of this proposed
7 Ordinance to be held in the City Commission meeting room, First Floor, City Hall, in the City of
8 Gainesville; and

9 **WHEREAS**, pursuant to law, at least 10 days notice has been given by publication in a
10 newspaper of general circulation notifying the public of the second Public Hearing of this proposed
11 Ordinance to be held in the City Commission meeting room, First Floor, City Hall, in the City of
12 Gainesville; and

13 **WHEREAS**, Public Hearings were held pursuant to the published notice described above
14 during which the parties in interest and all others had an opportunity to be and were, in fact, heard.

15 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE**
16 **CITY OF GAINESVILLE, FLORIDA:**

17 **Section 1.** The City Commission finds that the Area described in Section 2 of this Ordinance
18 (hereinafter referred to as the "Area") is contiguous and reasonably compact to the present corporate
19 limits of the City of Gainesville, and that no part of the Area is within the boundary of another
20 municipality or county. The City Commission finds the Area to be within its Reserve Area and the
21 annexation does not create an enclave. The City Commission finds the Area is developed for urban
22 purposes because it has a total resident population of at least two persons per acre of land included
23 within its boundaries.

1 **Section 2.** The following described Area is annexed and incorporated within the corporate
2 limits of the City of Gainesville, Florida:

3 See Legal Description attached hereto as Exhibit "A", and
4 made a part hereof as if set forth in full.
5

6 **Section 3.** Subject to the provisions of Section 4 of this Ordinance, the corporate limits of the
7 City of Gainesville, Florida, as set forth in Appendix I, Charter Laws of the City of Gainesville, are
8 amended and revised to include the Area described in Section 2 within the corporate limits of the City
9 of Gainesville, Florida.

10 **Section 4.** Pursuant to Section 8 of the Act, this Ordinance shall be submitted to a vote of the
11 registered electors of the Area described in Section 2 of this Ordinance at a referendum on annexation
12 to be held during the next General Election. The General Election shall be held on Tuesday, November
13 4, 2008. The referendum shall be conducted by the Alachua County Supervisor of Elections
14 (“Supervisor”) in accordance with the provisions of the Act and Chapter 9, Gainesville Code of
15 Ordinances, as applicable. The City Manager is authorized and directed to pay all lawful expenses
16 associated with this election.

17 **Section 5.** The Clerk of the Commission is authorized to publish notice of the referendum on
18 annexation as prescribed by law.

19 **Section 6.** Pursuant to Section 8 of the Act, the language to appear on the ballot of the
20 referendum election so called shall be:

21 "For annexation of property described in Ordinance Number 080137 of
22 the City of Gainesville"

24 "Against annexation of property described in Ordinance Number
25 080137 of the City of Gainesville"

1 **Section 7.** In accordance with Section 171.062, Florida Statutes, the Alachua County land use
2 plan and zoning or subdivision regulations shall remain in full force and effect in the Area described in
3 Section 2 of this Ordinance until the City adopts a comprehensive plan amendment that includes the
4 annexed area. The Gainesville Code Enforcement Board and code enforcement officers shall have
5 jurisdiction to enforce these regulations during the interim period through the Gainesville Code
6 Enforcement Board process as described in Division 8 of Article V of Chapter 2 of the Code of
7 Ordinances of the City of Gainesville and the Civil Citation Process, as described in Division 6 of
8 Article V of Chapter 2 of said Code. During the interim period, the City may rezone properties in the
9 annexed area to an Alachua County Zoning classification/category that conforms with the Alachua
10 County Comprehensive Plan.

11 **Section 8.** (a) Except as provided in subsection (b) below, all persons who are lawfully
12 engaged in any occupation, business, trade or profession within the area described in Section 2 of this
13 Ordinance, as of June 1, 2009, shall have the right to continue such occupation, business, trade or
14 profession.

15 (b) Except as provided in subsection (c) below, all persons who are lawfully engaged
16 in any construction trade, occupation or business within the Area described in Section 2 of this
17 Ordinance, as of June 1, 2009, and who possess a valid certificate of competency issued by Alachua
18 County shall have the right to continue the construction trade, occupation, or business within the entire
19 corporate limits of the City of Gainesville, including the Area described in Section 2 of this Ordinance,
20 subject to the terms, conditions and limitations imposed on the certificate by Alachua County, and
21 provided that such persons register the certificate with the Building Inspections Department of the City
22 of Gainesville and the Department of Business and Professional Regulation of the State of Florida, if
23 applicable, on or before 4:00 p.m. on June 1, 2010.


1 (c) All persons lawfully engaged in any occupation, business, trade or profession
2 within the Area described in Section 2 of this Ordinance on or after June 1, 2009, shall obtain a
3 business tax receipt from the City of Gainesville for the term commencing on October 1, 2009, which
4 receipt shall be issued upon payment of the appropriate fee in accordance with the Gainesville Code of
5 Ordinances in effect on October 1, 2009.

6 **Section 9.** If any portion of this Ordinance is declared by a court of competent jurisdiction to
7 be invalid or unenforceable, such declaration shall not be deemed to affect the remaining portions of
8 this Ordinance.


9 **Section 10.** The Clerk of the Commission is directed to submit a certified copy of this
10 Ordinance to: 1) the Executive Office of the Governor; 2) the Florida Department of State; and 3) the
11 Clerk of the Circuit Court of the Eighth Judicial Circuit in and for Alachua County, Florida.

12 **Section 11.** Sections 1, 4, 5, 6, 9, and 11 of this Ordinance shall become effective immediately
13 upon adoption. Sections 2, 3, 7, 8 and 10 shall become effective at 12:01 a.m. on June 1, 2009, unless
14 there is a tie vote or majority vote against the annexation at the general election called in Section 4 of
15 this Ordinance.

ARCHER ROAD TO THE SOUTHWEST CORNER OF THE LANDS KNOWN AS EXHIBIT "A", PARCEL 25 AS DESCRIBED IN OFFICIAL RECORDS BOOK 3048, PAGE 502, ALACHUA COUNTY RECORDS (HEREAFTER ABBREVIATED AS ORB, __ PAGE __ ACR), SAID CORNER ALSO BEING THE INTERSECTION OF THE NORTHERLY RIGHT-OF-WAY LINE OF SOUTHWEST ARCHER ROAD AND THE EASTERLY RIGHT-OF-WAY LINE OF SOUTHWEST 40TH BOULEVARD AND THE EXISTING CITY LIMIT LINE AS PER ORDINANCE # 070722; THENCE RUN NORTHERLY ALONG SAID CITY LIMIT LINE AND SAID EASTERLY RIGHT-OF-WAY LINE TO THE SOUTHWEST CORNER OF THE LANDS AS DESCRIBED IN ORB 1805, PAGE 1000 ACR; THENCE RUN NORTHEASTERLY ALONG THE SOUTH LINE OF SAID TRACT TO THE SOUTHEAST CORNER OF SAID TRACT; THENCE RUN IN A GENERAL NORTHWESTERLY DIRECTION ALONG THE EASTERLY PERIMETER OF SAID TRACT TO THE NORTHMOST CORNER OF SAID TRACT; THENCE RUN SOUTHWESTERLY ALONG THE NORTH LINE OF SAID TRACT AND THE SOUTH LINE OF THE LANDS KNOWN AS EXHIBIT "A", PARCEL 4 AS DESCRIBED IN 3048, PAGE 502 ACR TO THE SOUTHWEST CORNER OF SAID TRACT, SAID CORNER ALSO BEING A POINT ON THE EASTERLY RIGHT-OF-WAY LINE OF AFOREMENTIONED SOUTHWEST 40TH BOULEVARD; THENCE RUN NORTHWESTERLY ALONG THE WEST LINE OF SAID TRACT AND SAID EASTERLY RIGHT-OF-WAY LINE TO THE NORTHWEST CORNER OF SAID TRACT; THENCE RUN NORTHEASTERLY ALONG THE NORTH LINE OF SAID TRACT TO THE SOUTHEASTERLY CORNER OF THE LANDS AS DESCRIBED IN ORB 3546, PAGE 464 ACR; THENCE RUN NORTH ALONG THE EAST LINES OF SAID TRACT AND THE LANDS AS DESCRIBED IN ORB 3366, PAGE 1040 ACR TO THE NORTHEAST CORNER OF THE LANDS AS DESCRIBED IN ORB 3366, PAGE 1040 ACR, SAID CORNER BEING ON THE SOUTHERLY RIGHT-OF-WAY LINE OF SOUTHWEST 33RD PLACE; THENCE RUN WEST ALONG SAID SOUTHERLY RIGHT-OF-WAY LINE TO A POINT ON THE SOUTHERLY
