
Requests for floodplain information doubled, and requested community support letters to FEMA increased six times.

## Letter of Map Change<sup>#061148</sup>



Letter of Map Change application will be FAVORABLE if property or building is higher than the base flood elevation (BFE).

Advantages: Advantages: Not required to carry flood insurance and may obtain a preferred risk policy Increase resale value of property

Disadvantages: Must obtain a FEMA Elevation Certificate

### **FEMA Grandfather Rules**

Flood insurance discounts offset the financial impact of map change to property owners.

- For those who have maintained continuous flood insurance coverage.
- For those who originally built in compliance with existing Flood Insurance Rate Maps.

#### **Community Rating System Discount**

Points are awarded for floodplain management activities that reduce the risk of flooding in the community.


### **Revalidation Letter**

When new Flood Insurance Rate Maps are issued, all existing Letters of Map Change are suspended. FEMA issues a Revalidation Letter that tells you if a letter is;



#### Mile Run – Digital Migration Error<sup>48</sup>






# Duckpond Neighborhood Meeting 11/14/06#061148
