3	An ordinance of the City of Gainesville, Florida, to vacate, abandon		
5	and close a portion of the right-of-way located along Southwest 2 <sup>nd</sup> Place

13	WHEREAS, pursuant to Section 30-192 of the Code of Ordinances of the City of		
14	Gainesville, an application was initiated to vacate, abandon and close a certain portion of the right-		
15	of-way located along Southwest 2 <sup>nd</sup> Place between Southwest 10 <sup>th</sup> Street and Southwest 7 <sup>th</sup> Terrace,		
16	lying between lots 6, 7 and 8, as shown on the Plat of University Place, as more specifically described		
17	herein; and		
18	WHEREAS, notice was given and publication made as required by law and a public		
19	hearing was held by the City Plan Board on July 22, 2010; and		
20	WHEREAS, at least ten (10) days notice has been given of the public hearing once by		
21	publication in a newspaper of general circulation notifying the public of this proposed ordinance		
22	and of the public hearings in the City Commission meeting room, First Floor, City Hall, in the City		
23	of Gainesville; and		
24	WHEREAS, notice has also been given by mail to all owners of property abutting the		
25	portion to be vacated prior to the adoption of this ordinance; and		
26	WHEREAS, prior to the public hearings the application was presented to and approved

by the appropriate Departments of the City; and

1	WHEREAS, the City Commission finds that it is in the public interest to vacate; abandon		
2	and close the street subject to a public utilities easement with conditions as set forth herein.		
3	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE		
4	CITY OF GAINESVILLE, FLORIDA:		
5	Section 1. The following described right-of-way in the City of Gainesville no longer		
6	serves a public purpose and is hereby vacated, abandoned and closed for use by the public		
7	generally:		
8 9	See Legal Description attached hereto as Exhibit "A", and made a part hereof as if set forth in full.		
10	Section 2. The City reserves unto itself, its successors and assigns a public and private		
11	utilities easement over, under, across and through the right-of-way described in Exhibit "A",		
12	attached hereto and made a part hereof, for the purpose of installing, maintaining and operating		
13	public and private utilities.		
14	Section 3. The Clerk of the Commission or designee is authorized to record a true copy		
15	of this Ordinance in the Public Records of Alachua County, Florida.		
16	Section 4. If any word, phrase, clause, paragraph, section or provision of this ordinance		
17	or the application hereof to any person or circumstance is held invalid or unconstitutional, such		
18	finding shall not affect the other provisions or applications of the ordinance which can be given		
19	effect without the invalid or unconstitutional provisions or application, and to this end the		
20	provisions of this ordinance are declared severable.		
21	Section 5. All ordinances, or parts of ordinances, in conflict herewith are to the extent of		
22	such conflict hereby repealed.		
23	Section 6. This ordinance shall become effective immediately upon final adoption.
