4       **An ordinance of the City of Gainesville, Florida, amending the**  
5       **Zoning Map Atlas and rezoning certain property, as more**  
6       **specifically described in this Ordinance, from the City of**  
7       **Gainesville zoning categories of “Public Services and Operations**  
8       **(PS) District” and “Conservation (CON) District” to the City of**  
9       **Gainesville zoning category of “Business Industrial (BI) District,”**  
10       **located in the vicinity of 2900 Northeast 39th Avenue, commonly**  
11       **known as the Alachua County Fairgrounds and Cooperative**  
12       **Extension Office and consisting of approximately 74.48 acres;**  
13       **providing a severability clause; providing a repealing clause; and**  
14       **providing an effective date.**

18       **WHEREAS,** publication of notice of a public hearing was given that the Zoning Map  
19 Atlas be amended by rezoning certain property from the City of Gainesville zoning categories of  
20 “Public Services and Operations (PS) District” and “Conservation (CON) District” to the City of  
21 Gainesville zoning category of “Business Industrial (BI) District;” and

22       **WHEREAS,** notice was given and publication made as required by law and a public  
23 hearing was held by the City Plan Board on July 23, 2009; and

24       **WHEREAS,** the City Commission finds that the rezoning of the property described  
25 herein will be consistent with the City of Gainesville 2000-2010 Comprehensive Plan; and

26       **WHEREAS,** at least 10 days notice has been given once by publication in a newspaper of  
27 general circulation notifying the public of this proposed ordinance and of a Public Hearing in the  
28 City Commission meeting room, City Hall, City of Gainesville; and

29       **WHEREAS,** Public Hearings were held pursuant to the published and mailed notices

1 described above at which hearings the parties in interest and all others had an opportunity to be and  
2 were, in fact, heard.

3 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE**  
4 **CITY OF GAINESVILLE, FLORIDA:**

5 **Section 1.** The Zoning Map Atlas of the City of Gainesville is amended by rezoning the  
6 following described property from the City of Gainesville zoning categories of “Public Services  
7 and Operations (PS) District” and “Conservation (CON) District” to the City of Gainesville  
8 zoning category of “Business Industrial (BI) District.”

9 See Legal Description of Parcel 1 (being rezoned from PS to BI)  
10 attached hereto as Exhibit "A" and made a part hereof as if set forth  
11 in full.

12 See Legal Description of Parcel 2 (being rezoned from CON to BI)  
13 attached hereto as Exhibit "B" and made a part hereof as if set forth  
14 in full.

15 Parcel 1, Parcel 2, and Parcel 3 (unaffected by this ordinance) are  
16 visually depicted for ease of reference on the sketch attached as  
17 Exhibit “C” and made a part hereof as if set forth in full. In the event  
18 of conflict between the legal descriptions set forth in Exhibits “A”  
19 and “B,” and the sketch in Exhibit “C,” Exhibits “A” and “B” shall  
20 prevail.

24 **Section 2.** The City Manager is authorized and directed to make the necessary changes in  
25 the Zoning Map to comply with this Ordinance.

26 **Section 3.** If any word, phrase, clause, paragraph, section or provision of this ordinance  
27 or the application hereof to any person or circumstance is held invalid or unconstitutional, such  
28 finding shall not affect the other provisions or applications of the ordinance which can be given  
29 effect without the invalid or unconstitutional provisions or application, and to this end the

1 provisions of this ordinance are declared severable.

2  
3 **Section 4.** All ordinances, or parts of ordinances, in conflict herewith are to the extent of  
4 such conflict hereby repealed.

5 **Section 5.** This ordinance shall become effective immediately upon final adoption;  
6 however, the rezoning shall not become effective until the amendment to the City of Gainesville  
7 2000-2010 Comprehensive Plan adopted by Ordinance No. 090298 becomes effective as  
8 provided therein.



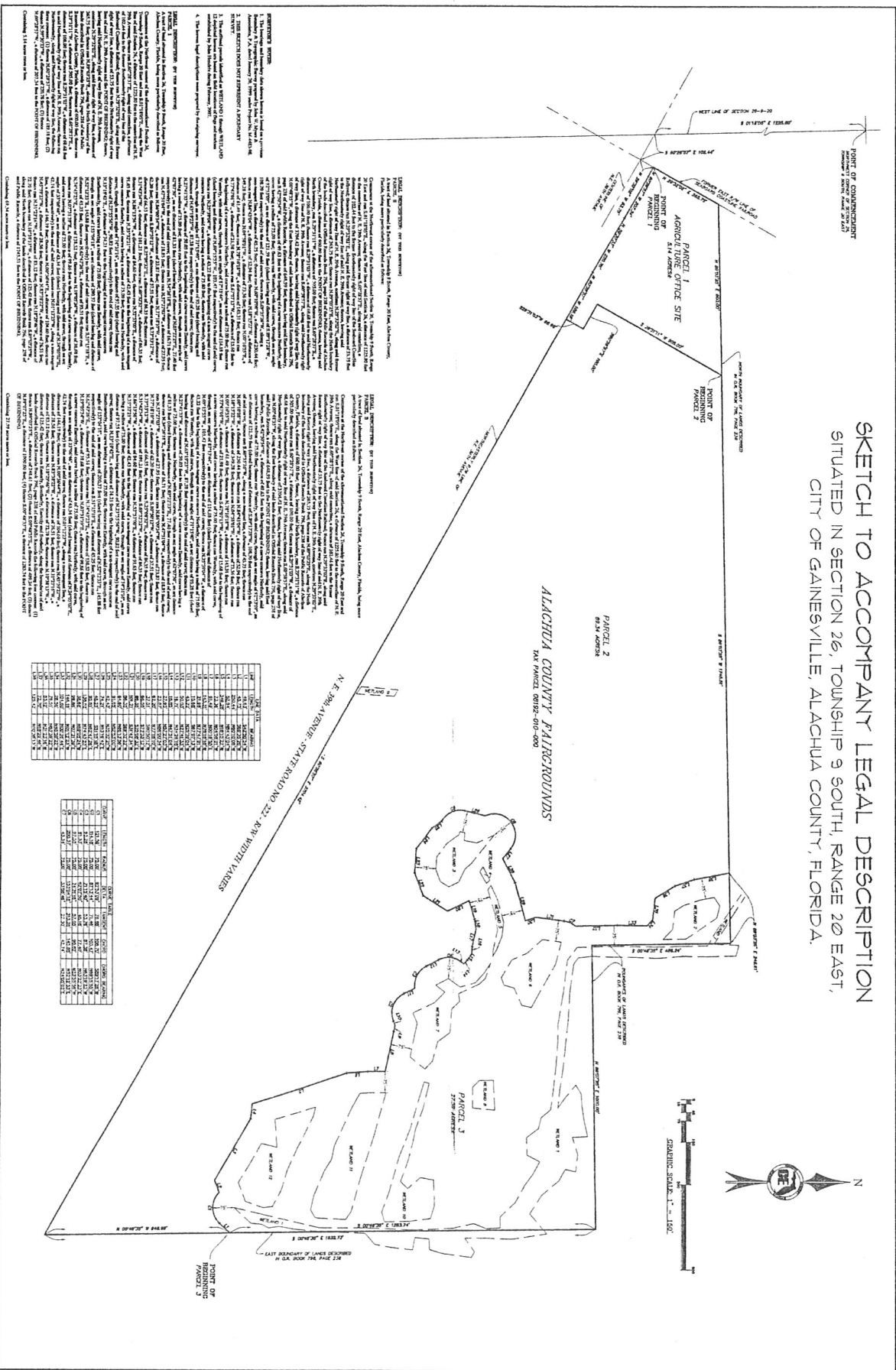
