Charter Officer Evaluations (B)

Explanation: Audit and Finance and Legislative Committee requested Human Resources to research the possibility of having City employee benefits applied to a temporary appointment in the Office of the Clerk of the Commission in a manner similar to that used by the University of Florida.

A summary of information provided by the University of Florida's Human Resources Department regarding classes of employees and benefits is provided as backup.

Should the City Commission wish to pursue benefits for this position, three options to consider are:

 Hire assistant as a regular employee with the understanding that the individual may be subject to lay-off at the end of the Mayor's term in office, provided the position is no longer necessary.
Create a term-limited regular position which would require a charter revision as well as changes to the pension and other benefit plans.3. Create the ability for temporary employees to accrue benefits which would require changes to all the benefit plans and the pension plan.

Both options #1 and #2 will require the development of a new job description and pay grade and normally would require a competitive selection process.

Fiscal Note: Depends upon the option selected.

100507.Update on Funding Regional Transit System (RTS) Routes and Associated
Americans with Disabilities Act (ADA) Service Outside Gainesville City
Limits (B)

This item is an update on funding Regional Transit System (RTS) Routes and Associated Americans with Disabilities Act (ADA) service outside Gainesville City Limits as requested by the Audit, Finance and Legislative Committee.

Explanation: On November 4, 2010, a request was made of the Audit, Finance and Legislative Committee to approve policy criteria for transit service rates for fixed route services outside Gainesville City limits. At that time, a proposed policy including the objective, definitions, directives, and the formula for the service rate was submitted.

The following information is an update to that policy as shown on the backup document: 1) the portion of the formula discounting depreciation was eliminated to address capital costs concerns and an additional cost of \$7.30 has been included in the rate calculation; 2) GRU rates have been reviewed and appear to have a surcharge minimum of 10% which RTS does not recommend but has included in the formula to give the committee additional information; and 3) RTS does not recommend including the Consumer Price Index (CPI) to bring costs to actual costs because the CPI appears to have been very low or negative the past few years.

Fiscal Note: Revenue generated by the service rate will cover any operating expenses associated with the service.

		This item is to discuss City Commission Strategic Initiative 4.3: Increase opportunities for civic engagement. The item includes an update to the AFL Committee and seeks direction for civic engagement activities in fiscal year 2011 and beyond.			
1	Explanation:	: This Strategic Initiative was first introduced by the City Commission in December, 2006 at the Strategic Planning Retreat. The Initiative was later adopted and added to the Strategic Plan on February 12, 2007.			
In FY 2007, a team of employees representing various dep the City was formed. The team compiled a matrix detailing			-		

opportunities for civic engagement. The matrix identified over 50 different boards, committees, and groups that offer citizens the opportunity to participate in City government.

In FY 2008, a meeting in each of the City Commission Districts was held to inform citizens of capital projects in their neighborhoods, provide Departmental updates, and relevant information on the City Budget. General Government also conducted a Citizen Survey to give residents the opportunity to provide feedback on the quality of community and government services

In FY 2009, four town hall meetings were held in each of the City Commission Districts to discuss the upcoming budget and the Evaluation and Appraisal Report (EAR) for the City's Comprehensive Plan update. In addition, over 50 residents participated in the Citizens Academy, which provides education on topics such as public safety, energy supply, and infrastructure projects.

In FY 2010, the City continued to provide public forums for community engagement through the Citizen's Academy, public workshops and Town Hall meetings. In addition, the City was awarded a grant from the Center on Government Performance of the National Center for Civic Innovation to engage the public in their performance measurement and reporting process.

Many of the programs that have been offered by the City since this initiative was adopted continue as normal business operations. The purpose of this agenda item is to discuss civic engagement activities for FY 2011 and beyond.

Fiscal Note: There is no immediate fiscal impact of this discussion.
