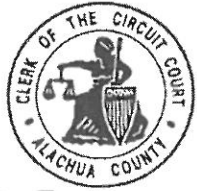

HUMAN RIGHTS VIOLATIONS, CONSTITUTIONAL AMENDMENTS VIOLATIONS, FLORIDA BILL OF RIGHTS VIOLATIONS, EXTORTION UNDER THE COLOR OF LAW, TRESPASS, UNLAWFUL ARREST, DETAINMENT, KNOWINGLY WRONGFUL AND MALICIOUS EVICTION, EMOTIONAL DISTRESS, PERSONAL LOSS[S], PERSONAL PROPERTIES LOST

The Plaintiff, request that the requested actions be so ordered in violation of my civil (federal/state) rights their actions as described by the Constitutional Amendment 4th,5th, Florida Statutes chap 83: 83.241 (removal of tenant process), 702.10(FORECLOSURE) ;

Facts

On or about February 4, 2010, I was illegally, knowingly/maliciously detained and prevented from my rightfully possessed properties without due process [1381, 1313, 07624-004-000 NE 192 Avenue Montechocha.

I have/had a lawful contract to possess said properties; along with the right to possess other properties under the Florida statute (adverse possession). The defendants were provided proper notification and presented legal documents at the scene clearly demonstrating their error, to which, they knowingly ignored. Furthermore, the defendants had been provided verbal notification of such errors months prior, along with the noticed that they were trespassing.

Plaintiff, also states the defendants acted unlawfully as they were well aware that the addressed property was over **half mile** (approx.) in distance and **separated by several boundaries and several separate property owners**; as notified by the e-911 persons. However, even as they possessed such knowledge they maliciously and purposely **robbed** me of my property and belongings.

Again, they were made well aware of said purchase contract had previously been ruled valid by Chief Justice Judge Aymer L. Curtin, with direct guidance to the seller of the said property.

RELIEF SOUGHT

The Plaintiff seeks an immediate injunction/stay against all listed agencies and should be granted *him immediate and full use of said properties without the unlawful threat of arrest, and or terrorist methods*. Plaintiff respectfully suggest that since there isn't any court orders legally ordering him to stay away from such said properties that this request be fulfilled immediately.

Plaintiff, is seeking a change of venue; Jacksonville, Orlando, Tampa counties, as due to the status of this case and the hostilities that he had been force to incur by all agencies involved the chances of this case being viewed impartially and in *just eyes is immeasurable*.


