Note: For the first month, this fee shall be prorated based on the gross revenues collected for the number of days the franchise is in place that month.

6. Annual franchise fee for construction and demolition debris collection:

i. For each vehicle having ten or more wheels 1,500.00

ii. For each vehicle having more than five and fewer than ten wheels 1,000.00

iii. For each vehicle having four or five wheels 500.00

Note: For the first year, this fee shall be prorated based on the gross revenues collected for the number of days the franchise is in place that year.

c. Commercial recycling/recovered materials collector registration

Application or renewal of registration (§ 27-86) 50.00
