State Law Enforcement Contraband Forfeiture Trust Fund (LECFTF) Funding for "You and the Law" Crime Prevention Program (NB)

This item requests that the City Commission appropriate and expend \$14,000 in funds from the State Law Enforcement Contraband Forfeiture

Trust Fund for Gainesville Police Department's for "You and the Law" Program.

Explanation: The Police Department was awarded \$15,000 from the Florida Department of Law Enforcement's Byrne Grant Program to facilitate a new initiative by the Department to educate the youth about the laws and the consequences of violating them. The Program will involve instruction regarding laws and law enforcement and how it relates to juveniles in our community. A Law Professor with the University of Florida will facilitate classes for at-risk youth, young adults, parents and Neighborhood Crime Watches. Participants will be provided an informational booklet. This program is a continuation of the Police Department's effort to assist high-risk youth that have the greatest likelihood of becoming part of the criminal justice system.

Fiscal Note: Funds for this expenditure are available in the State Law Enforcement Contraband Forfeiture Trust Fund, as allowed under Florida State Statue 932.7055. The current balance of the State Law Enforcement Contraband Forfeiture Trust Fund is \$54,057.

RECOMMENDATION

The City Commission authorize the appropriation of \$14,000 from the State Law Enforcement Contraband Forfeiture Trust Fund to assist with the implementation of the "You and the Law" program.

State Law Enforcement Contraband Forfeiture Trust Fund (LECFTF) Funding for "Black on Black Crime Taskforce" Crime Prevention Programs (NB)

This item requests that the City Commission appropriate and expend \$8,000 in funds from the State Law Enforcement Contraband Forfeiture Trust Fund for Gainesville Police Department's for "Black on Black Crime Taskforce" crime prevention programs.

Explanation: The Black on Black Crime Taskforce was formed in 1984 to assist the Gainesville Police Department address crime issues in the African American community. Today the Black on Black Crime Task Force is a cooperative effort between the Gainesville Police Department and citizens who work in partnership to devise innovative strategies to reduce crime, particularly in disadvantaged areas of the community. Staff support from the Gainesville Police Department is provided to the organization by performing such tasks as

recording minutes at the monthly meetings, sending out advance notice of these meetings, and fulfilling many other administrative functions for the Task Force. The Taskforce also assists the Police Department in its continuing efforts to assist high-risk youth that have the greatest likelihood of becoming part of the criminal justice system.

Fiscal Note: Funds for this expenditure are available in the State Law Enforcement Contraband Forfeiture Trust Fund, as allowed under Florida State Statue 932.7055. The current balance of the State Law Enforcement Contraband Forfeiture Trust Fund is \$54,057.

RECOMMENDATION

The City Commission authorize the appropriation of \$8,000 from the State Law Enforcement Contraband Forfeiture Trust Fund to assist with the "Black on Black Crime Taskforce" crime prevention programs.

Route 75 Transit Services Agreement with Alachua County Board of **County Commissioners (B)**

Explanation: The City and County had an Agreement for the City to provide public transit services to residents and visitors on Route 75 that expired on September 30, 2010. Fiscal Note: The City will receive \$402,557 of revenue from the County in quarterly payments of \$100,639.25 for the period of October 1, 2010, through September 30, 2011.

FY 2010 HUD Continuum of Care Homeless Assistance Program Grant Application (NB)

The City of Gainesville will participate in the development of an application for HUD Continuum of Care Homeless Assistance Program funding by serving as the sponsor grantee for two local projects. This item supports City Commission Strategic Goals & Initiatives for Human Capital to continue implementation of the 10 Year Plan to End Homelessness.

Explanation: In response to a Notice of Funding Availability (NOFA) for the Continuum of Care Homeless Assistance Program published on September 20, 2010, to supplement funding for local homeless programs; this NOFA establishes the funding criteria for the Continuum of Care (CoC) Homeless Assistance Grant Program. HUD is making available approximately \$1.68 billion in Fiscal Year 2010 for the programs. The purpose the CoC Homeless Assistance Grant Program is to reduce the incidence of homelessness in CoC communities by assisting homeless individuals and families to move to self-sufficiency and permanent housing.

The City's Housing & Community Development division in collaboration with the North Central Florida Continuum of Care prepared a grant application in the amount of \$896,630 for 2010 Continuum of Care program funds. Since 1995, the City of Gainesville has coordinated with other Gainesville/Alachua County organizations to submit applications for funding under HUD's CoC. Local organizations again have an opportunity to apply for homeless assistance funding through HUD's CoC. Two projects, for which the City has served as the applicant and grantee, will be included in the 2010 CoC grant application: 1) Meridian Behavioral Healthcare, Inc. "HOPE" Program: \$98,849 one-year renewal. This project provides supportive services and transitional housing for up to nine mentally ill and dually diagnosed homeless individuals at leased scattered sites; and 2) VETSPACE, Inc. "VETSPACE": \$105,098 for a one-year renewal to provide supportive services and transitional housing for up to 13 homeless veterans in leased scattered sites.

If funded, the City would act as fiscal agent for the receipt and disbursal of grant funds for the Meridian Behavioral Healthcare "HOPE" Project and "VETSPACE" transitional housing program via subrecipient agreements. The other projects, if awarded, would be administered directly by the project sponsors. The deadline for submitting the CoC application to HUD is November 18, 2010.

Fiscal Note: This application requests an estimated \$203, 947 in funding from HUD for two projects. This amount may vary based on HUD's final approval of the grant funding for the projects. The City of Gainesville would act as the fiscal agent for both projects, and all required matching funds for the grant will be provided by Meridian Behavioral Healthcare, Inc. and VETSPACE, Inc. as required by HUD.

RECOMMENDATION

The City Commission: 1) authorize the City Manager or designee to apply for grant funding in collaboration with the North Central Florida Continuum of Care under the U.S. Department of Housing & Urban Development (HUD) Continuum of Care Homeless Assistance Program and to act on behalf of the City of Gainesville in all matters pertaining to said grants; and 2) authorize the City Manager to execute subrecipient agreements with Meridian Behavioral Healthcare, Inc. and VETSPACE, Inc., if selected by HUD to receive funding through the Continuum of Care Homeless Assistance Program, subject to approval by the City Attorney as to form and legality.

100459. Amendment to Contract for Elevator Services (NB)

Staff recommends extending the term of the contract with ThyssenKrupp

extension to the contract on November 6, 2008.

Elevator Corporation for elevator maintenance and inspection services for General Government and GRU equipment.

Explanation: A three-year contract with ThyssenKrupp Elevator Corporation (TKE) for elevator maintenance and inspection services for all General Government and GRU was approved by the City Commission on December 12, 2005. The contract provides for two (2) two-year extensions of the contract upon mutual agreement of the parties. The City Commission approved the first two-year

General Government facilities covered by this contract include City Hall, the Old Library, SW Parking Garage, Thomas Center, Gainesville Police Department and the Thelma Bolton Center. GRU facilities include the Deerhaven and Kelly Generating Stations, Murphree Water Treatment Plant, South Energy Center and the GRU Administration Building. Collectively there are 22 elevators, 2 manlifts and 2 chairlifts maintained under this contract. In addition, TKE performs annual elevator inspections as required by State regulations.

TKE has been responsive in meeting the City's requirements for elevators services. TKE has agreed to maintain the existing prices for the first year of the two-year extension. If requested, a price adjustment for the final year of the extension will be tied to the CPI for the previous twelve months. The annual cost for the maintenance and inspection services is currently \$44,700. This amount would vary only if new equipment is added to the contract or non-routine repairs are required.

Fiscal Note: Funds are available in the FY 2011 budgets and will be requested in subsequent year budgets.

RECOMMENDATION

The City Commission: 1) authorize the General Manager, or his designee, to negotiate and execute a two-year amendment to extend the term of the contract with ThyssenKrupp Elevator Corporation for elevator maintenance and inspection services for General Government and GRU equipment, subject to approval of the City Attorney as to form and legality; and 2) approve the issuance of purchase orders for these services to ThyssenKrupp Elevator Corporation in amounts not exceeding budgeted funds for each fiscal year of the contract, pending final appropriation of funds for each year.

100405. EXPANSION OF EASTSIDE COMMUNITY REDEVELOPMENT AREA (B)

Ordinance No. 100405

An ordinance of the City of Gainesville, Florida amending Division 9 of Chapter 2 of the Code of Ordinances of the City of Gainesville relating to Community Redevelopment, amending Section 2-410.3 by expanding the boundaries of the Eastside Community Redevelopment Area; amending Section 2-415 by establishing the base values of the expanded areas for purposes of tax increment calculations; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

Explanation: Pursuant to the requirements of State law, on January 15, 2009, the City Commission adopted Resolution No. 080712 and Resolution 080713 finding certain areas (referred to as Study Area 1 and Study Area 2) adjacent to the Eastside Community Redevelopment Area to be blighted areas and further finding that rehabilitation, conservation or redevelopment or a combination

thereof, of the blighted areas is necessary in the interest of the public health, safety, morals or welfare of the residents of the City of Gainesville.

On April 19, 2010, the CRA Board approved amending the Eastside Redevelopment Plan in its entirety to include Study Area 1 and Study Area 2

On July 15, 2010, the City Commission adopted Resolution No. 090966, approving the Eastside Redevelopment Plan, as amended in its entirety to include Study Area 1 and Study Area 2. In addition, the City Commission directed the City Attorney to prepare and the Clerk to advertise an ordinance amending the City Code of Ordinances to update the legal description of the Eastside Redevelopment Area to include Study Area 1 and Study Area 2 and to establish the base values of Study Area 1 and Study Area 2 for purposes of tax increment calculations.

The figures for the base values were calculated by CRA staff based on data provided by the Alachua County Property Appraiser's Office.

This ordinance requires two public hearings. If this ordinance is passed on first reading, second and final reading will be held on November 18, 2010.

RECOMMENDATION The City Commission adopt the proposed ordinance.

ADDITIONAL SIGNAGE FOR MULTIPLE-FAMILY DEVELOPMENTS (B)

Ordinance No.100101; Petition PB-10-21-TCH.

An ordinance of the City of Gainesville, Florida, amending Section 30-318(d)(2) of the Land Development Code, related to permanent development identification signs and structures for subdivisions and neighborhoods; by allowing additional signage for multi-family developments with more than one frontage and increasing the maximum size of the secondary entrance signs; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

Explanation: PLANNING AND DEVELOPMENT SERVICES DEPARTMENT STAFF REPORT

This petition and ordinance amend Section 30-318 (d)(2) of the City's Land Development Code, to allow additional and larger identification signage for multiple-family developments with frontage on multiple streets. Section 30-318(d)(2) specifically regulates identification signage for multiple-family residential developments, community residential homes of over fourteen residents, mobile home parks and other allowed uses in multiple-family zoning districts. Currently, a multiple-family development is allowed one identification sign of up to 24 square feet in size, excluding structural elements and decorative features. This can be a single sign unit with two faces or a single-faced sign

mounted on each side of the entrance into the development. If the development has more than one approved entrance, one additional sign designed for identification purposes only, on a structure not exceeding four square feet in size, is currently allowed at each entranceway.

The Petitioner requested a code revision to allow an additional frontage sign of up to 128 square feet in size and up to 12' in height and to allow more than identification information to be displayed on the sign.

City staff did not support the Petitioner's request, as most multiple-family developments are located within residential zoning districts and a proposed sign area of 128 square feet is larger than a primary sign is allowed to be, even in commercially zoned areas. The largest sign allowed in the City is 96 square feet for commercial development with a frontage exceeding 300 linear feet. In addition, the proposed twelve-foot height is taller than the ten-foot maximum height allowed in commercial zones.

However, staff recognizes the need for identification signage on more than one frontage, even if the development does not have an entrance on that frontage, and the staff recommended language addresses that issue.

After public notice was published in the Gainesville Sun on April 6, 2010, the City Plan Board held a public hearing on April 22, 2010. The City Plan Board heard the petition and, by a vote of 6-0, recommended approval with a further revision to allow the maximum sign area of the identification sign at a secondary entrance to be up to 16 square feet, rather than the up to 4 feet that is currently allowed by code.

The Petitioner supports the petition as recommended by City staff and revised by the City Plan Board.

REZONE THE ALACHUA COUNTY FAIRGROUNDS AND COUNTY EXTENSION SERVICE SITE FROM PS (PUBLIC SERVICES AND OPERATIONS DISTRICT) AND CON (CONSERVATION DISTRICT) TO BI (BUSINESS INDUSTRIAL DISTRICT) (B)

Ordinance No. 090299; Petition PB-09-81 ZON

An ordinance of the City of Gainesville, Florida, amending the Zoning Map Atlas and rezoning certain property, as more specifically described in this Ordinance, from the City of Gainesville zoning categories of "Public Services and Operations (PS) District" and "Conservation (CON) District" to the City of Gainesville zoning category of "Business Industrial (BI) District," located in the vicinity of 2900 Northeast 39th Avenue, commonly known as the Alachua County Fairgrounds and Cooperative Extension Office and consisting of approximately 74.48 acres; providing a severability clause; providing a repealing clause; and providing an effective date.

Explanation: PLANNING AND DEVELOPMENT SERVICES DEPARTMENT STAFF REPORT

The property consists of approximately 74.48 acres of the property that is the site of the Alachua County Fairgrounds and the Cooperative Extension Office. Approximately 5.14 acres located at the westernmost corner of the property has Public Facilities (PF) land use and Public services and operations district (PS) zoning; the other 69.34 acres has Conservation (CON) land use and zoning. This petition does not include the eastern 27.6 acres owned by the County, much of which is wetland and all of which has CON land use and zoning. The property is adjacent to and south of the Gainesville Regional Airport. The property fronts NE 39th Avenue and Waldo Road and the majority of it is within the Enterprise Zone.

In 2003, Plan East Gainesville (PEG) was accepted by the City of Gainesville and Alachua County. The summary report for PEG recommends that the existing fairgrounds site be used as an "office and industrial mixed-use employment center." The proposed rezoning to Business industrial district (BI) addresses this identified need of the City (and County). The related, proposed land use change to Business Industrial (Petition PB-09-80LUC) is consistent with redevelopment policies established in the City's Future Land Use Element (FLUE). FLUE Policy 2.1.5 states that "The City shall strive to implement certain land use-related elements of Plan East Gainesville, including, but not limited to: ... (b) Coordinating with Alachua County in its development of a strategy for the Alachua County fairgrounds for creation of a mixed-use employment center;..." The BI zoning district implements the Business Industrial land use category, which was developed specifically to be applied to properties near the Airport and to other areas of the City where office, business, commercial or industrial uses are desired and residential use is not appropriate. The BI future land use category was added to the Future Land *Use Element following approval by the City Commission on October 16, 2008.* The BI zoning district was approved by the City Commission on March 19, 2009.

This petition and ordinance propose to implement a portion of PEG and the Future Land Use Element as stated above by amending the zoning of the property from PS and CON to BI. The proposed BI zoning is particularly compatible at this location near the Gainesville Regional Airport that fronts two arterial roadways (NE 39th Avenue and Waldo Road), both of which are also state roads (SR 222 and SR 24, respectively).

After public notice in the Gainesville Sun, the Plan Board held a public hearing on July 23, 2009, heard presentations by staff and the applicant, discussed the proposed rezoning, and by a vote of 7-0, recommended that the City Commission approve the petition.

CITY ATTORNEY MEMORANDUM

This ordinance requires two hearings. Should this ordinance pass on first reading, second and final reading will be held on November 4, 2010.

100374. Rezone property MH to RSF-4 (B)

Petition PB-10-85 ZON. Tom Spain, agent for Villas at 39th, LLC and property owners of record. Rezone property from MH (12 units/acre mobile home residential district) to RSF-4 (8 units/acre single-family residential district). Located west of Northeast 2nd Street, north of Northeast 35th Avenue, and east of the CSX railroad ROW in the 3500-3700 block of Northeast 1st Terrace, Northeast 1st Way, and North Main Terrace.

Explanation: This is a quasi-judicial item.

This petition request is to rezone 100 mobile home condominium parcels from MH (12 units/acre mobile home residential district) to RSF-4 (8 units/acre single-family residential district) in a development known as Villas at 39th.

Prior to becoming Villas at 39th, this was Varsity Mobile Home Villas mobile home park. The combined parcels are approximately 14 (MOL) acres in size. The proposed zoning is consistent with the existing Residential Low (R-L) future land use category on the property.

The existing MH zoning would allow a maximum of 168 mobile homes on the 14 acre site, with a minimum lot size of 3,000 square feet. The proposed zoning would allow a maximum of 112 single family homes at the site, with a minimum lot size of 4,300 square feet. The proposed rezoning is a reduction in maximum allowable density (allowing 56 fewer dwelling units at the site).

The subject parcels are located west of NE 2nd Street, north of NE 35th Ave., and east of the CSX Railroad ROW in the 3500-3700 block of NE 1st Terrace, NE 1st Way, and North Main Terrace. Lots 10-21 abut NE 2nd Street (see map on page 1). The property is surrounded on the east and south by industrial zoning and industrial uses. Immediately to the west of the property is an active CSX railroad line. To the west of that is the City's Public Works compound (PS zoning). The property immediately to the north is zoned BUS (General business district).

The Plan Board discussed the petition and recommended approval with a 6-0 vote.

Public notice was published in the Gainesville Sun on August 10, 2010. The Plan Board held a public hearing on August 26, 2010.
