A Resolution promulgating the City of Gainesville 2000-2010 Comprehensive Plan; incorporating the Future Land Use Element, the Recreation Element, the Housing Element, the Historic Preservation Element, the Capital Improvement Element, the Urban Design Element, the Cultural Affairs Element, the Intergovernmental Coordination Element, the Solid Waste Element, the Stormwater Management Element, the Potable Water/Wastewater Element, and the Concurrency Management Element as part of the City of Gainesville 2000-2010 Comprehensive Plan; and providing an immediate effective date.

WHEREAS, the City Commission adopted the Future Land Use Element of the City of Gainesville by Ordinance No. 000620 on March 4, 2002; and

WHEREAS, the City Commission adopted the Recreation Element of the City of Gainesville by Ordinance No. 00514 on March 4, 2002; and

WHEREAS, the City Commission adopted the Housing Element of the City of Gainesville by Ordinance No. 991268 on March 4, 2002; and

WHEREAS, the City Commission adopted the Historic Preservation Element of the City of Gainesville by Ordinance No. 000769 on March 4, 2002; and

WHEREAS, the City Commission adopted the Capital Improvement Element of the City of Gainesville by Ordinance No. 000768 on March 4, 2002; and

WHEREAS, the City Commission adopted the Urban Design Element of the City of Gainesville by Ordinance No. 990852 on July 24, 2000; and

WHEREAS, the City Commission adopted the Cultural Affairs Element of the City of Gainesville by Ordinance No. 990215 on July 24, 2000; and

WEREAS, the City Commission adopted the Intergovernmental Coordination Element of the City of Gainesville by Ordinance No. 990063 on December 13, 1999; and

WHEREAS, the City Commission adopted the Solid Waste Element of the City of Gainesville by Ordinance No. 990216 on July 24, 2000; and

WHEREAS, the City Commission adopted the Stormwater Management Element of the City of Gainesville by Ordinance No. 990217 on July 24, 2000; and

WHEREAS, the City Commission adopted the Potable Water/Wastewater Element of the City of Gainesville by Ordinance No. 990731 on July 24, 2000; and

WHEREAS, the City Commission adopted the Concurrency Management Element of the City of Gainesville by Ordinance No. 981310 on December 13, 1999; and

WHEREAS, the state land planning agency has issued notices of intent to find the aforesaid elements in compliance; and no petitions have been filed so that the findings of the agency have become final agency action as provided in Chapter 163, Florida Statutes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA;

Section 1. The City of Gainesville Future Land Use Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.

Section 2. The City of Gainesville Recreation Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.

- **Section 3.** The City of Gainesville Housing Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.
- **Section 4.** The City of Gainesville Historic Preservation Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.
- **Section 5.** The City of Gainesville Capital Improvement Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.
- **Section 6.** The City of Gainesville Urban Design Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.
- **Section 7.** The City of Gainesville Cultural Affairs Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.
- **Section 8.** The City of Gainesville Intergovernmental Coordination Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.
- **Section 9.** The City of Gainesville Solid Waste Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.
- **Section 10.** The City of Gainesville Stormwater Management Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.
- **Section 11.** The City of Gainesville Potable Water/Wastewater Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.
- **Section 12.** The City of Gainesville Concurrency Management Element is promulgated as an Element and made a part of the City of Gainesville 2000-2010 Comprehensive Plan.

Section 13. The Elements promulgated in Sections 1 thru 12 inclusive of this Resolution shall supersede all like Elements of the City of Gainesville 1991-2001 Comprehensive Plan.

Section 14. This resolution shall be effective immediately upon adoption.
