A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA, AUTHORIZING THE GRANT OF A PERPETUAL EASEMENT TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE.

ON MOTION of Commissioner _____, seconded by Commissioner _____, the following Resolution was adopted;

WHEREAS, the State of Florida Department of Transportation proposes to improve, construct and maintain a traffic signal mast arm, curb ramp and pedestrian signal at the intersection of Southwest 16th Street and north side of Southwest 16th Avenue, in Alachua County, Florida; and

WHEREAS, it is necessary that portions of certain public right of way, Southwest 16th Street, maintained by the **CITY OF GAINESVILLE, FLORIDA**, be used by the State of Florida Department of Transportation for the signal light and improvements; and

WHEREAS, said use is in the best interest of the City; and

WHEREAS, the State of Florida Department of Transportation has made application to said City to execute and deliver to the State of Florida Department of Transportation a Subordination Agreement in favor of the State of Florida Department of Transportation, for the purpose of to improving, constructing, and maintaining a traffic signal mast arm, curb ramp and pedestrian signal at the intersection of Southwest 16th Street and Southwest 16th Avenue thereon with the construction to be undertaken by the Florida Department of Transportation and said request having been duly considered.

NOW THEREFORE, BE IT RESOLVED by the City Commissioners of the **CITY OF GAINESVILLE, FLORIDA**, that the application of the State of Florida Department of Transportation for a Subordination Agreement, is for transportation purposes which is in the public or community interest and for public welfare; that a Subordination Agreement, in favor of the State of Florida Department of Transportation in the **CITY OF GAINESVILLE, FLORIDA**, should be drawn and executed by this City Commissioners.
