

RESOLUTION NO. 150752

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA, RECOMMENDING APPROVAL OF ONESIXTYOVERNINETY, INC. AS A QUALIFIED TARGET INDUSTRY BUSINESS; AGREEING TO EXTEND DATES ASSOCIATED WITH BUDGETED AND APPROPRIATED FUNDS OF TWENTY EIGHT THOUSAND DOLLARS (\$28,000) AS LOCAL FINANCIAL SUPPORT IN THE QUALIFIED TARGET INDUSTRY TAX REFUND PROGRAM; PROVIDING AN IMMEDIATE EFFECTIVE DATE.

WHEREAS, the business under consideration, ONESIXTYOVERNINETY, INC. is a branding and public relations agency; and,

WHEREAS, ONESIXTYOVERNINETY, INC. has corporate offices located at 1 South Broad Street in Philadelphia, PA and proposes an expansion of its business unit to Gainesville, FL; and,

WHEREAS, ONESIXTYOVERNINETY, INC. has located to its new site in an Enterprise Zone designated pursuant to Section 290.0065, Florida Statutes, within the City of Gainesville, Alachua County, Florida at 21 SE 2nd Place in downtown Gainesville; and,

WHEREAS, ONESIXTYOVERNINETY, INC. in its new site, will employ 35 employees with an average annual compensation of \$90,000 per year; and,

WHEREAS, Enterprise Florida, Inc. represents that the average private sector annual wage in Alachua County, Florida is \$34,918; and,

WHEREAS, ONESIXTYOVERNINETY, INC. intends to make a capital investment of \$500,000 over the next three years; and,

WHEREAS, ONESIXTYOVERNINETY, INC. intends to apply for the Qualified Target Industry Tax Refund for an Enterprise Zone location, pursuant to Section 288.106(3), Florida Statutes; and,

WHEREAS, the request by ONESIXTYOVERNINETY, INC. has been reviewed by Enterprise Florida's primary economic development partner in Gainesville/Alachua County, the Gainesville/Alachua County Council for Economic Outreach and Gainesville Area Chamber of Commerce; and

WHEREAS, on August 13, 2013, the Alachua County Board of County Commissioners approved funding 50% of the local financial support (\$28,000) towards this project and on December 10, 2013 and February 23, 2016 adopted amended Resolutions; and,

WHEREAS, the Gainesville City Commission finds that the expenditure of City funds as local financial support for ONESIXTYOVERNINETY, INC. constitutes a valid public purpose; and,

WHEREAS, in August 2013, by resolution No. 130159 the City Commission approved ONESIXTYOVERNINETY, INC. as a Qualified Target Industry business and in January 2014 the City Commission altered the eligibility period of ONESIXTYOVERNINETY, INC. by adopting Resolution No. 130589 and repealing Resolution No. 130159; and

WHEREAS, the City Commission wishes to alter the eligibility period and intends this Resolution to replace Resolution No. 130589 upon the effective date of the Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FL:

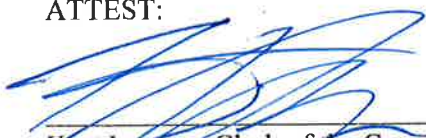
1. That the Commission finds, determines, and declares that the recitals in the preamble are true and correct, and hereby incorporates them by reference.
2. That in accordance with Section 288.106(4)(a)(10), Florida Statutes, the City Commission recommends that ONESIXTYOVERNINETY, INC. be approved as a Qualified Target Industry (QTI) Business.
3. That the City of Gainesville has calculated that this project's average annual wage of \$90,000 is more than 200% of Alachua County's average private sector annual wage as determined by Enterprise Florida.
4. That the City agrees to budget and appropriate up to \$28,000 as local financial support over a four year period commencing in Fiscal Year 2015 and running through Fiscal Year 2018 to the Florida Economic Development Trust Fund in the event ONESIXTYOVERNINETY, INC. is certified as a QTI Business and locates its business within the City of Gainesville corporate limits and specifically within the City's established Enterprise Zone.
5. This resolution shall take effect immediately upon its adoption. Upon becoming effective, this Resolution replaces and repeals Resolution No. 130589.

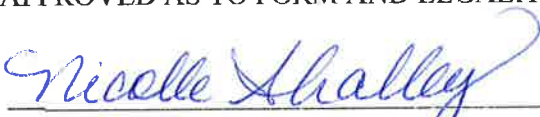
