

**EIGHTH AMENDMENT TO CONTRACT BETWEEN
THE CITY OF GAINESVILLE d/b/a GAINESVILLE REGIONAL UTILITIES, AND
RED COATS, INC. d/b/a ADMIRAL SECURITY SERVICES, INC.
FOR SECURITY SERVICES FOR VARIOUS GRU FACILITIES**

THIS EIGHTH AMENDMENT is made and entered into this 14 day of June, 2017, by and between the **CITY OF GAINESVILLE**, a Florida municipal corporation, **d/b/a GAINESVILLE REGIONAL UTILITIES (“GRU”)**, and **RED COATS, INC. d/b/a ADMIRAL SECURITY SERVICES, INC. (“Contractor”)**, a Maryland corporation, authorized to do business in the State of Florida, with its principal place of business at 4401 East West Highway, Suite 500, Bethesda, Maryland 20814, individually referred to as “Party” or collectively as “Parties.”

WHEREAS, On November 6, 2008, GRU and the Contractor entered into a Contract For Security Services For Various GRU Facilities (“Initial Contract”), which has been extended through November 30, 2018 by way of amendments; and

WHEREAS, the Parties wish to amend to Contract to add facilities to the scope of services.

NOW, THEREFORE, in consideration of the covenants contained herein, the Parties agree to the following:


1. Paragraph 1 of the Initial Contract is amended to add to the facilities listed in GRU’s Invitation to Bid No. 2009-003, Section Four (Special Provisions) paragraph 4.0:
 - a. City Hall, 200 E. University Avenue, Gainesville FL 32601; and
 - b. Thomas Center, 302 N.E. 6th Avenue, Gainesville, FL 32601.
2. Billing for the above facilities (General Government) shall be separate from the billing for the other City facilities (GRU), and shall be sent to:

3. All other terms and conditions of the Initial Contract, as amended, except as modified herein, shall remain in full force and effect.
