14	newspaper of general circulation notifying the public of this proposed ordinance and of a Public	
15	Hearing in the Auditorium of City Hall in the City of Gainesville; and	
16	WHEREAS, the Public Hearings were held pursuant to the published notice described at	
17	which hearings the parties in interest and all others had an opportunity to be and were, in fact,	
18	heard; and	
19	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE	
20	CITY OF GAINESVILLE, FLORIDA:	
21	Section 1. Subsection (a) "Registration" of Section 2-611, "Registration, amendment,	
22	termination and administration procedures" of Article VIII of Chapter 2 of the Code of	
23	Ordinances of the City of Gainesville, shall be amended to read as follows:	
24	Sec. 2-611. Registration, amendment, termination and administration procedures.	
25	(a) Registration.

27	(1) Declaration of registered domestic partnership. A declaration of registered	
28	domestic partnership shall be filed with the clerk of the commission and shall contain the	
29	names and addresses of the applicants who shall swear or affirm under penalty of perjury	
30	that each partner:	
31	a. Is at least 18 years old and competent to contract;

1 2	b.	Is not married to, or a member of another registered domestic	
3		partnership or civil union, with anyone other than the co-applicant.	
4	c.	Agrees to share the common necessities of life and to be responsible	
5		for each other's welfare.	
6 7	d.	Considers the mutual residence to be his or her primary residence.	
8	e.	Considers himself or herself to be a member of the immediate family	
9		of the other partner; and	
10	f.	Agrees to mutually support the other by contributing in some fashion	
11		not necessarily equally, to maintain and support the registered	
12		domestic partnership.	
13	<u>g.</u>	Are not related by blood to one another in any way which would	
14		prohibit legal marriage in the State of Florida.	
15	Section 2. It is the intention of the City Commission that the provisions of Section 1 of		
16	this ordinance shall become and be made a part of the Code of Ordinances of the City of		
17	Gainesville, Florida, and that the Sections and Paragraphs of this Ordinance may be renumbered		
18	or relettered in order to accomplish such intentions.		
19	Section 3 . If any	word, phrase, clause, paragraph, section or provision of this ordinance	
20	or the application hereof to any person or circumstance is held invalid or unconstitutional, such		
21	finding shall not affect the other provisions or applications of the ordinance which can be given		
22	effect without the valid or unconstitutional provisions or application, and to this end the		
23	provisions of this ordinar	nce are declared severable.	
24	Section 4. All or	dinances, or parts of ordinances, in conflict herewith are to the extent of	

such conflict hereby repealed.
