Ordinance No. 0-99-24, Petition No. 202PSZ-98PB

An ordinance of the City of Gainesville, Florida, amending the Zoning Map Atlas and rezoning certain lands within the City from "RMF-5: 12 units/acre single-family/multiple-family residential district" to "PS: Public services and operations district"; by permitting a parking area and stormwater drainage system as accessory uses to the principal permitted use of the administration of public health programs and associated health care, medical and social services on adjacent property without the requirement of a preliminary development plan; located in the vicinity of 2145 Southeast 2nd Avenue; providing a severability clause; providing a repealing clause; and providing an effective date.

Recommendation: The City Commission adopt the proposed ordinance.

27	required by law and a public hearing was held by the City
28	Plan Board on November 19, 1998; and

- WHEREAS, the City Commission finds that the rezoning

- WHEREAS, public hearings were held pursuant to the

- Section 2. The specific uses permitted on the property -
- 2 described in Section 1 of this ordinance are the accessory
- 3 uses of a parking area and stormwater drainage system to the
- 4 principal uses of the administration of public health
- 5 programs and associated health care, medical and social
- 6 services on adjacent property.
- 7 Section 3. The City Manager is authorized and directed to
- 8 make the necessary changes in the Zoning Map Atlas to comply
- 9 with this ordinance.
- Section 4. The City Commission finds that a preliminary
- 11 development plan is not required in connection with this
- 12 rezoning ordinance.
- 13 Section 5. If any section, sentence, clause or phrase of
- 14 this ordinance is held to be invalid or unconstitutional by
- 15 any court of competent jurisdiction, then said holding shall
- 16 in no way affect the validity of the remaining portions of
- 17 this ordinance.
- 18 Section 6. All ordinances, or parts of ordinances, in
- 19 conflict herewith are to the extent of such conflict hereby
- 20 repealed.
- 21 Section 7. This Ordinance shall become effective
- 22 immediately upon passage; however, the rezoning shall not
- 23 become effective until the amendment to the City of

2	Ordinance No. 980727 becomes effective as provided therein.
