Gainesville Police Department (GPD) Off-site Improvements (NB)

Assistant City Manager Fred Murry briefly introduced this item, and Captain Lonnie Scott gave an update. Mr. Murry stressed that any improvements will need to be discussed with the community stakeholders that will be held in the new GPD building after it opens in the spring.

After discussion, Chair Hawkins passed the gavel to Commissioner Chase. The following motion was made by Commissioner Wells, second by Commissioner Hawkins, approved 2-1 with Commissioner Chase in dissent.

MOTION: Recommend that the City Commission direct staff to: move forward with the proposal to create on-street parking on 6th Street and some capital improvements for the area surrounding the new GPD building; 2) host a community meeting with stakeholders to discuss any proposed improvements; and 3) remove this item from the CDC referral list.
