FY06-08 Outside Agency Funding (NB)

This item requests that the City Commission approve the funding recommendation of the Gainesville/Alachua County Cultural Affairs Board (GACCAB) for the Outside Agency cultural grants program, which is budgeted for a total of \$60,000.

Explanation: The Gainesville/Alachua County Cultural Affairs Board uses the Cultural Plan to evaluate Outside Agency grant applications, assessing each application for its ability to meet criteria specified in the Plan, including arts and cultural accessibility, education and audience development.

> A public scoring workshop was conducted on April 12, 2006 to review applications and at its May 10th meeting, the GACCAB approved final funding recommendations.

Applications were received from fourteen agencies this year, twelve of which are recommended for funding. Of the remaining two applications, one agency was ineligible for consideration, and the other did not score sufficient points to receive funding. Evaluation of applicants takes into consideration the City's Cultural Plan, the applicants' fiscal and artistic history, verification of 501 (c) 3 status as a "not-for-profit" agency, and how well the agency's application meets specific criteria outlined in the grant guidelines such as, audience development, project management and program merit. Prior to submitting their applications, all applicants are provided with a complete copy of evaluative criteria.

Applicants must score 75 points or better to be eligible for funds.

In keeping with the City's two-year budget cycle, grant awards are for a two-year period, similar to granting procedures of the State's Division of Cultural Affairs. Applicants' requests and award amounts are based on a tiered funding system for small, medium and large agencies, with request caps based on agencies' last closed fiscal year expenditures budget. This results in awards more closely aligned with each agency's operational needs.

Fiscal Note: Funding for Outside Agency grants is set at \$60,000. This funding level has been consistent since FY1997 and is targeted toward smaller cultural arts agencies. The Cultural Affairs Division also allocates \$85,000 in funding for a category called Professional Arts Producing Institutions which targets larger cultural arts agencies.

FY 2006-07 Funding Recommendations and Annual Action Plan (Application) for Community Development Block Grant (CDBG) and **HOME Investment Partnerships Program (HOME) Funds. (B)**

The City Commission is being asked to consider recommendations for allocating CDBG and HOME funds for FY 2006-07 and authorize the submission of an Annual Action Plan (application) to HUD based on the allocations that are approved by the City Commission.

Explanation: Each year, part of the City's CDBG funds is set aside for the City Housing Division, Block Grant Administration and Public Works projects. Likewise, part of the City's HOME funds is set aside for the City Housing Division and Block Grant Administration. This year, an additional \$28,500 has been set aside for a City playground improvement project and \$50,000 for a homeless capital initiative. The remaining CDBG and HOME funds are made available to nonprofit outside agencies and other public agencies through a competitive process that involves review and recommendations by the Citizens Advisory Committee for Community Development (CACCD).

> The CACCD has formulated its recommendations on allocating the "competitive" CDBG and HOME funds as outlined in its report to the City Commission. Copies of the CDBG and HOME applications that were reviewed by the CACCD are on file in the Office of the Clerk of the Commission. The City Manager's recommendations for funding the City Housing Division, Block Grant Administration, Public Works, and other set-asides are outlined in the Special Revenue Fund section of the proposed FY 2006-07 General Government Financial and Operating Plan.

> The Annual Action Plan outlines the specific agencies and activities to be funded through CDBG and HOME in the next fiscal year. It will be based on decisions made by the City Commission at the July 27, 2006, budget workshop regarding FY 2006-07 CDBG and HOME funding allocations. The City's Annual Action Plan must be submitted to HUD by August 14, 2006.

Fiscal Note: The total projected CDBG and HOME program expenditures for FY 2006-07 is \$2,395,337. Sources of funds are: CDBG - \$1,479,481 and HOME - \$915,856.

RECOMMENDATION

Recommended Motion: The City Commission: 1) consider recommendations from the CACCD and City Manager and take action as appropriate to allocate FY 2006-07 CDBG and HOME funds; 2) authorize the City Manager or designee to prepare and submit the FY 2006-07 Annual Action Plan (Application), including all understandings and assurances contained therein, to the U.S. Department of Housing and Urban Development (HUD) for financial assistance under the Community Development Block Grant (CDBG) Program and HOME Investment Partnerships (HOME) Program and to act on behalf of the City of Gainesville in all matters pertaining to the CDBG and HOME Programs; and 3) authorize the City Manager to

execute subrecipient agreements with those outside agencies that are designated to receive FY 2006-07 CDBG and HOME funding, subject to approval by the City Attorney as to form and legality.

Alternative Recommendation A: The City Commission consider recommendations from the CACCD and City Manager and defer action until a later date.
