Section 2. Article IV, Vending Booths and Itinerant Vendors, consisting of sections 19-91 through 19-98, City of Gainesville Code of Ordinances, is amended in its entirety as follows:

4 ARTICLE IV. VENDING BOOTHS AND ITINERANT VENDORS*

5 Sec. 19-91. Definitions.

6 A "vending booth" is a temporary wheeled cart-mounted food or retail establishment located on 7 public property, or a permanent structure constructed by the city on the Gainesville Community 8 Plaza. A vending booth cannot be propelled by an internal combustion engine, electric motor or 9 other similar mechanical device. A vending booth, except a permanent structure constructed by 10 the city on the Gainesville Community Plaza, must be capable of being moved from place to 11 place, but may be stationary during the business day. Examples of vending booths are, but are 12 not limited to, the following: coffee/cappuccino stands; stands selling muffins, bagels and other 13 bakery items; ice cream carts; snow cone and Italian Ice carts; fast-food carts; souvenirs carts; 14 and newsstands.

15 An "itinerant food vendor" is a <u>natural person or business entity</u>, corporation, company or

1	business that sells immediately consumable food products and non-alcoholic beverage items
2	from a non-permanent structure cart, trailer, or vehicle (an "itinerant food vending conveyance")
3	at a fixed location on private property.
4	Sec. 19-92. Annual permit.
5	(a) A vending booth permit or itinerant food vendor permit is required and can be renewed
6	annually upon payment of the fee specified in Appendix A of this Code. Vending booth and
7	itinerant food vendor permits expire on October 1 and are delinquent if not renewed. Vending
8	booth and itinerant food vendor permits initially received between April 1 and September 30 are
9	subject to one-half the permit fees for the initial period ending September 30. In order to obtain a
10	vending booth permit, written approval of the proposed vending booth is required from the fire
11	department and code enforcement office, who will approve the application if it meets the
12	requirements of this article and all applicable fire safety regulations. In order to obtain an
13	itinerant food vendor permit, a minor site plan, meeting the requirements of Article VII of the
14	land development code, must be approved by the city manager or designee, including written

16	permit must include sufficient information for staff to determine that all of the applicable
17	requirements of section 19-97 are met.

20	manager or designee will examine the photographs and shall determine the acceptability of the
21	vending booth or itinerant food vending conveyance as to design and appearance. Items to be
22	considered will be size, material and color of the vending booths or itinerant food vending
23	conveyance, canopy and signs.
