4	An ordinance of the City of Gainesville, Florida, amending the
5	Zoning Map Atlas and rezoning certain property, as more
6	specifically described in this Ordinance, from the Alachua
7	County zoning category of "Conservation (C-1) district" to the
8	City of Gainesville zoning category of "PS: Public services and
9	operations district"; to allow a public utility – wastewater
10	treatment plant and accessory uses and facilities as a use
11	permitted by right without approval of a preliminary development
12	plan; located in the vicinity of 7100 Southwest 41st Place,
13	commonly known as "Kanapaha Water Reclamation Facility";
14	providing a severability clause; providing a repealing clause;
15	and providing an immediate effective date.

17	WHEREAS, publication of notice of a public hearing was given that the Zoning Map
18	Atlas be amended by rezoning certain property annexed into the City from the Alachua County
19	zoning category of "Conservation (C-1) district" to the City of Gainesville zoning category of
20	"PS: Public services and operations district"; and
21	WHEREAS, notice was given and publication made as required by law and a public
22	hearing was held by the City Plan Board on August 28, 2008; and
23	WHEREAS, the City Commission finds that the rezoning of the property described herein

WHEREAS, pursuant to law, an advertisement no less than two columns wide by 10 inches long was placed in a newspaper of general circulation and of the public hearing to be held in the City Commission Meeting Room, First Floor, City Hall, in the City of Gainesville at least seven (7) days

15 .	Section 2. The City Commission finds that a preliminary development plan is not required
16	in connection with this rezoning.
17	Section 3 The use permitted by right on the property described in Section 1 of this
18	Ordinance is public utility - wastewater treatment plant and accessory uses and facilities.
19	Section 4. If any word, phrase, clause, paragraph, section or provision of this ordinance
20	or the application hereof to any person or circumstance is held invalid or unconstitutional, such
21	finding shall not affect the other provisions or applications of the ordinance which can be given
22	effect without the invalid or unconstitutional provisions or application, and to this end the


