Following is a summary of our agreements with Swing & Sway Dance Club and the Old Time Dance Society:

SWING & SWAY

An agreement has been signed between Swing & Sway and the City of Gainesville. This agreement runs from October 1, 2001 through Sept.ember 30, 2003.

In recognition of their long time use of the building, as part of the new agreement, they were allowed to keep their current reservations until December 2001. Starting in January 2002, Swing and Sway will change from alternate Fridays to a schedule of alternate Fridays and Thursdays. This will result in three Fridays now being available for the general public instead of two.

Further, we have "employed" them through this agreement to put on the dances. They will pay expenses of the bands, and other expenses, including insurance, and the City will provide the facility and a monitor at no charge. Swing & Sway has agreed to split in annual profits that exceed 125% of expenses with the City of Gainesville at 50% to each party. To accomplish this, Swing and Sway has also agreed to provide a monthly financial statement, reflecting membership dues and admissions collected.

Swing and Sway has also provided complimentary memberships that will be available to city residents, who will then be able to participate in these events without regard to costs.

OLD TIME DANCE SOCIETY

An agreement has been signed between Old time Dance Society and the City of Gainesville. This agreement runs from October 1, 2001 through September 30, 2003.

In recognition of their long time use of the building, as part of the new agreement, they were allowed to keep their current reservations until December 2001. Starting in January 2002, Old Time Dance will switch from first and third Saturdays, and instead will hold dances on the First Sunday and Third Saturday of each month. This will result in three (3) Saturdays each month being available for the general public instead of two.

Further, we have "employed" them through this agreement to put on the dances. They will pay expenses of the bands, and other expenses, including insurance, and the City will provide the facility and a monitor at no charge. Old Time Dance has agreed to split annual profits that exceed \$13,000 (approx, see contract) with the City of Gainesville at 50% to each party.

To accomplish this, Old Time Dance has also agreed to provide a monthly financial statement, reflecting membership dues, donations and admissions collected.

Old Time Dance has also provided complimentary memberships that will be available to city residents, who will then be able to participate in these events without regard to costs.

SUMMARY

For both groups, Swing & Sway, and Old Time Dance, we have agreed to meet in April 2003, six (6) months prior to the expiration of the agreements to begin negotiations on any future agreements. Both groups understand that the City will negotiate those agreements in terms that meet the needs of the programs and facilities at that time, and that some aspects of the current agreements may in fact change. The agreements were set at two years to accommodate the unique needs each group has in booking musical talent for blocks of time into the future. Dates and performance rates can be guaranteed by booking 6 to 12 months in advance.

We think these facility use agreements will be an asset to the city residents. These dances are a great resource of recreation and social entertainment for seniors and all those who enjoy swing era and old time music. These agreements will allow staff to maximize the number of weekend days available for spontaneous rentals, at the same time accommodating long time tenants of the building, and keeping those groups financially viable, all at the same time. We look forward to the next two years of dances offered by Swing & Sway, and Old Time Dance in the Thelma Boltin Center.
