

AMENDED RESOLUTION NO. 100182
PASSED _____

A Resolution of the City of Gainesville, Florida, amending Resolution No. 100182 passed on August 5, 2010 accepting FAA AIP Grant No. 3-12-0028-031-2010 from the US Department of Transportation, Federal Aviation Administration, and authorizing execution by the Mayor and the Clerk of the Commission on behalf of the City of Gainesville; and providing an immediate effective date.

WHEREAS, on June 30, 2010, the Gainesville-Alachua County Regional Airport Authority (GACRAA) approved a Project Application to the Department of Transportation, Federal Aviation Administration of the United States of America, for the following projects at Gainesville Regional Airport: South Airfield Lighting Vault Renovation, ALCS Upgrade and miscellaneous airfield electrical improvements; Taxiway A Rehabilitation & Crack Sealing; Rehabilitation of Taxiway C and prepare Wildlife Hazard Management Plan and acquire miscellaneous wildlife control equipment at the Gainesville Regional Airport; and

WHEREAS, on August 5, 2010, the Gainesville City Commission approved Resolution No. 100182 accepting FAA AIP Grant No. 3-12-0028-031-2010 from the US Department of Transportation, Federal Aviation Administration for the aforementioned projects with the Federal Share to be estimated up to \$2,244,794.00; and

WHEREAS, on August 20, 2010, the Federal Aviation Administration submitted a Grant Agreement Offer to the Gainesville Regional Airport inclusive of the following projects: Rehabilitate airfield electrical vault; and Rehabilitate Taxiway C (plus or minus 2,300 LF x 50 FT) at a Federal Share of \$1,427,834

WHEREAS, for the purpose of receiving Federal Grant funds, the FAA requires that the City of Gainesville and the Gainesville-Alachua County Regional Airport Authority both approve the Offer; and

WHEREAS, the Gainesville-Alachua County Regional Airport Authority, has previously endorsed Application for FAA funds for the project at the 95% level and formally approved its Resolution 10-030 to accept and authorize execution of the Grant Agreement at its meeting on June 30, 2010; and

WHEREAS, Gainesville Regional Airport staff has requested that the City of Gainesville approve the FAA Grant Agreement Offer subject to final approval by GACRAA;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:

Section 1. The City of Gainesville shall enter into FAA Grant Agreement 3-12-0028-031-2010, for the purpose of obtaining Federal aid in the development and operation of the Gainesville Regional Airport under Grant Agreement 3-12-0028-031-2010 that is to be implemented, constructed and operated by the Gainesville-Alachua County Regional Airport Authority in accordance with Chapter 2006-363, Laws of Florida.

Section 2. The City of Gainesville does hereby ratify and adopt all statements, representations, warranties, covenants and agreements contained in FAA Grant Agreement 3-12-0028-031-2010, and incorporated material referred to in the said amended Grant Agreement, and by such acceptance, and in reliance upon the Gainesville-Alachua County Regional Airport Authority's Chief Executive Officer assurances that the Gainesville-Alachua County Regional Airport Authority agrees to abide by all of the terms and conditions of said amended Grant Agreement, does agree to all of the terms and conditions thereof.

Section 3. That Craig Lowe, Mayor, is hereby authorized and directed to execute said Grant Agreement 3-12-0028-031-2010, on behalf of the City of Gainesville and Kurt M. Lannon, Clerk of the Commission, is hereby authorized and directed to impress the official seal of the City of Gainesville and to attest to said execution.

Section 4. This resolution shall take effect immediately upon adoption.
