090392. Vision for East University Avenue to Hawthorne Rd Corridor - 5 Points Area (B)

This item involves a request for the Community Development Committee to hear a presentation from Community Redevelopment staff on Eastern Gainesville - Vision, Infrastructure, and Achieving Results.

The Community Development Committee heard a presentation from CRA Project Coordinator Malcolm Kiner on East Gainesville Redevelopment Opportunities. Mr. Kiner gave a brief history of this item and proceeded to identify 3 potential redevelopment sites for more detailed discussion; the former Kennedy Homes redevelopment site, the GTEC properties, and the Shands property. The Committee reviewed and discussed the challenges and opportunities of each site as presented by Mr. Kiner.

MOTION: Direct City staff to work with CRA staff and continue to study the East Gainesville development sites and related parcels discussed in the presentation and further develop plans with focus on infrastructure, utilities, and land use. The Committee requested that this item be brought back within the next 60 days.

RECOMMENDATION *Community Development Committee: 1) receive presentation from staff; and 2) provide feedback and direction to staff as appropriate.*
