8	become and be made a part of the Code of Ordinances of the City of Gainesville, Florida, and
9	that the Sections and Paragraphs of this Ordinance may be renumbered or relettered in order to
10	accomplish such intentions.
11	Section 3. If any section, sentence, clause or phrase of this ordinance is held to be invalid or
12	unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect
13	the validity of the remaining portions of this ordinance.
14	Section 4. All ordinances, or parts of ordinances, in conflict herewith are to the extent of such
15	conflict hereby repealed.
16	Section 5. This ordinance shall take effect immediately upon adoption; provided however,
17	the fees and charges as provided for herein shall be applicable to rates and charges which are
18	due after 12:01 A.M., October 1, 2007.
